I Smt. Radha Basak, W/o. Late Bimal Basak, R/o. Uttar Ektiyasal, Dabgram, P.O. Sevoke Road, Dist.- Jalpaiguri, would like to inform you that on 13.05.2023 at around 10:00 am, my son Sri. Bapi Basak, and his wife Smt. Shuli Basak started to abuse me in filthy languages and also assaulted me with fists and blows without any reasons and at the same time my two brother-in-laws and their family members also joined in, their names are as follows 1. Sri. Basanta Basak, (Brother-in-law), S/o. Khagen Basak, his wife Smt. Aalpana Basak, W/o. Basanta Basak, his son namely, Sri. Tinku Basak, his daughter-in-law Smt. Ritika Basak, W/o. Tinku Basak, another son Sri. Biplab Basak, 2. Sri. Sameer Basak (Brother-in-law, S/o. Khagen Basak, his wife Smt. Kalpana Basak, W/o. Sameer Basak, and his daughter Miss. Mumun Basak, D/o. Sameer Basak, all of them started to beat me with lathi and as well as with fists and blows, because of which I have sustained multiple injuries on whole body specially on my both hip, I was totally helpless and there was no one to save me from their hands and when I became unconscious they also took away some valuable household items from my possession as well as Rs.20,000/- cash which was lying in my room but somehow with God's grace my daughter Smt. Baby Bhatia, W/o. Ratan Bhatia arrived in and when my daughter tried to stop them and saved me from their hands, they also assaulted my daughter and used filthy language against her, and also touched my daughter inappropriately and tried to pull her clothes.
