I smt Monika Singh w/o Sri Biswajit Singh,  
residence of Syoknagar Colony, ward no 46 P.O. Champasari,  
P.S. Pradhan Nagar, Siliguri, Dist - Darjeeling would like to  
inform you for your kind information and necessary  
action as follows.

1) That today dated 15/05/2023 at about 12.30 pm, when  
I along with my younger brother namely Gushar Kashyap  
was in my landed property situated at Debidanga main-  
Road, near petrol pump P.O. Champasari P.S. Pradhan Nagar  
Siliguri, that in the mean time Binod Goswami s/o.  
Ranjan Goswami, Babai @ Akash Das s/o. Ashit Das,  
Raju Basnet s/o. Dhan Bahadur Basnet, Rishi Mukherjee  
s/o. Munna Mukherjee, Vishal Saha s/o. Sibam Saha, Kala  
Saha, Bishnopada Saha both are s/o. Sibam Saha along with  
their 12-15 antisocial associates all are residing at  
the locality of Debidanga Bazar, Champasari P.S. Pradhan-  
Nagar, Siliguri, in the influence of Binod Kr Jaiswal  
came at my aforesaid landed property and without  
any reason attacked me and tear my saree and  
Blouse and molested me with wrongful intention  
and when I cried my brother came and opposed  
their intention and helped me but the all accused  
attacked to my brother's head and body by using iron-  
Rod, baton, khukri along with beat and Blow by  
using slang languages and my brother was  
graviously injured due to head injured and they  
snatched Golden chain from my brother's neck.  
And they started to break boundary wall, shops  
iron-gate etc.



By fire and house broken articles, and when I cried for help loudly then intervention of local people and my well-wishers they all accused & fled away with dire consequences, they any how are trying to grab my property and kill me, if anybody try to disturb, we will kill the whole family, and molest you in front of public. Dear Sir my younger brother has been admitted in District Hospital and Doctor said he is in critical condition and hanging between life and death.

So, under the above circumstances, I therefore request you kindly inquire the matter and immediate arrest the namely accused namely ① Binod Goswami ② Babai ③ Akash Das ④ Raju Basnet ⑤ Rishi mukherjee ⑥ Bishal Saha ⑦ Kala Saha ⑧ - Bishnupada Saha alongwith 12-15 antisocial persons as per provision of law and kindly seize my brothers golden ornaments from their custody and save our life, for this Act of kindness, I shall always be obliged to you.
