Arindam Chatterjee of Junction Traffic Guard, Siliguri Police Commissionerate do here by lodge written complaint against him to the effect that, on 15.05.2023 I along with C-871 Amit Oraon and C-1513 Santosh Barman while performing traffic regulation duty at NH-10, near Darjeeling More, Ps- Pradhan Nagar, Dist- Darjeeling found that, the above noted person was plying his Toto (E-rickshaw), as noted above on NH-10 by violating Govt.
