Sir,

In producing herewith three (03) arrested accused persons namely (1) Kiran Sen (26) @ Bikso, s/o-Late Nagen Sen, of-Santipara, PS-NJP, Dist-Jalpaiguri, (2) Pradip Mallick (24) @ Bittu, S/O-Paritosh Ch Mallick, of - Santipara, PS-NJP, Dist-Jalpaiguri, (3) Bappa Mallick (30), s/o-Paritosh Ch Mallick, of Santipara, PS-NJP, Dist-Jalpaiguri arrested u/s- 41 Cr.P.C along with following seized articles viz:

- (1) One iron rod measuring 30 inch (approx) in length from the possession of Kiran Sen which was kept on his right hand.
- (2) One Iron rod measuring 28 inch (approx) in length from the possession of Pradip Mallick which was kept on his right hand.
- (3) One sharp cutting Knife with wooden handle measuring 12 inch (approx) in length from the possession of Bappa Mallick which was kept on his right hand.
- (4) One Torch Light from the possession of Bappa Mallick.

I, SI Ganesh Roy of NBMC OP under Matigara P.S, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons and others to the effect that on 13.04.2023 at 23.35 hrs received a source information that 10/12 youths have assembled at Kawakhali Gaisal Mandir Shamsan Ghat under Matigara PS with a view to commit docoity at Kawakhali area. The fact was diarized in GDE vide NBMC OP GDE No- 358 dated 13.04.2023. Subsequently, after sharing the information with my superiors and as per their direction, I along with ASI Anupam Roy, ASI Dulal Dey, ASI Prem Bhakta Mallick, C/327 Barkat Ali Ahamed & C/1085 Mithun Debnath left for the place to work out the information with Govt vehicle bearing registration no WB 74 Q 8035.

At about 00.15 hrs after reaching at Kawakhali Gaisal Mandir Shamsan Ghat under Matigara PS, I met my source and as pointed by the source we started approaching towards the spot and cordoning off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence. But, seeing the police party approaching towards them they tried to flee away from the spot. On hot chase we managed to apprehend three accused persons along with seized articles from their possession as mentioned above who disclosed their name & address as (1) Kiran Sen (26) @ Bikso, s/o-Late Nagen Sen, of -Santipara, PS-NJP, Dist-Jalpaiguri, (2) Pradip Mallick (24) @ Bittu, S/O-Paritosh Ch Mallick, of - Santipara, PS-NJP, Dist-Jalpaiguri, (3) Bappa Mallick (30), s/o-Paritosh Ch Mallick, of Santipara, PS-NJP, Dist-Jalpaiguri.

However the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there and was planning to commit dacoity at Kawakhali area.

I thereafter, seized the above noted weapons & torch light under proper seizure in presence of witnesses and being acknowledged by the accused persons. The whole process of search & seizure was made in between 00.45 hrs to 01.20 hrs on 14.04.2023. Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons.

Hence, a specific case may kindly be started under proper section of law against the above noted accused persons namely (1) Kiran Sen (26) @ Bikso, s/o-Late Nagen Sen, of- Santipara, PS- NJP, Dist- Jalpaiguri, (2) Pradip Mallick (24) @ Bittu, S/O- Paritosh Ch Mallick, of - Santipara, PS- NJP, Dist- Jalpaiguri, (3) Bappa Mallick (30), s/o - Paritosh Ch Mallick, of Santipara, PS - NJP, Dist - Jalpaiguri and others and arrange for its investigation.


