In producing herewith two (02) accused persons namely (1) Nabankar Sarkar (M/34), S/O- Lt. Narayan Ch. Sarkar of Gurung Busty, Ward No. 03, PS Pradhan Nagar, Dist. Darjeeling and (2) Rohit Singha (M/21) S/O Nakul Singha of Gurung Busty, Ward No. 03, PS Pradhan Nagar, Dist. Darjeeling under arrest along with following articles under proper seizure;

1. One Gold colored I phone 12 Pro having IMEI 1 No. 356696119362965 and IMEI 2 356696119714199 with Sim No. 8116291301 seized from the exclusive possession of Nabankar Sarkar.
2. One Neon colored Oppo Mobile phone having IMEI 1 No. 866195054880597 and IMEI 2 No. 866195054880589 with Sim No. 9832397976 seized from the exclusive possession of Rohit Singha.
3. Rs. 3,000/- (Three thousand only in the following denomination of Indian Currency Notes);

Re. 500 X 2 = Rs. 2,000/-

Rs. 200 X 5 = Rs. 1,000/-

I, SI Abhishek Theengh of Pradhan Nagar PS, SPC do here by lodge this written complaint against the above noted accused persons namely Nabankar Sarkar (M/34), S/O- Lt. Narayan Ch. Sarkar of Gurung Busty, Ward No. 03, PS Pradhan Nagar, Dist. Darjeeling, Rohit Singha (M/21) S/O Nakul Singha of Gurung Busty, Ward No. 03, PS Pradhan Nagar, Dist. Darjeeling, Sourav of Maynaguri, PS Maynaguri, Dist. Jalpaiguri and others to the effect that on 16.05.2023 at 14.35 hrs., I received a secret source tip that a betting is going on in the house of one Nabankar Sarkar at Gurung busty under Pradhan Nagar PS. Accordingly, I diarized the fact in Pradhan Nagar PS GDE No-951 Dt. 16.05.2023 and consequently, as per your direction, I along with ASI Biplab Kumar Das, C/762 Mojebul Rahaman, CV-242 Rakesh Mangar and CV/646 Baban Das all of Pradhan Nagar PS, SPC left PS to work out the information.

At 15.10 hrs we reached at Gurung Busty and subsequently, being pointed, by my reliable source, I along my accompanied officers and force conducted raid in the living room at ground floor of the house of Nabankar Sarkar and found the above noted persons namely Nabankar Sarkar and Rohit Singha were equipped with the above noted 02 (two) number of mobile phones and was actively engaged in betting regarding the ongoing IPL Cricket match to be played between Lucknow Super Giants and Mumbai Indians which would commenced from 19.30 hrs. On being asked to the accused persons, they confessed that they were running an organized racket on betting for the ongoing IPL Cricket game through SKYEXCH.ART mobile apps.

During the raid, continuous updates were being received in the mobile phones of Nabankar Sarkar and Rohit Singha regarding the ongoing cricket match in between Lucknow Super Giants and Mumbai Indians and current betting price of the IPL Cricket.

Subsequently, I seized the above noted articles from the spot under proper seizure list in presence of witness. The seizure was made in between 15.10 hrs. to 15.25 hrs. Thereafter, I arrested the above noted accused persons namely Nabankar Sarkar and Rohit Singha observing all the formalities after informing the ground of their arrest.


On further being asked, they also disclosed that they have been dealing in this organized racket on betting for the last few months along with their co-associate namely Sourav of Maynaguri, PS Maynaguri, Dist. Jalpaiguri and others for their wrongful gain.

Hence it is evident that the above noted accused persons in pursuance of their criminal conspiracy were actively engaged in running of betting racket on the ongoing IPL Cricket matches for their wrongful gain and wrongful loss of others and cheating the public by undermining the game of cricket.

I, therefore pray before good office that a specific case may kindly be started against the above noted accused persons namely (1) Nabankar Sarkar (M/34), S/O- Lt. Narayan Ch. Sarkar of Gurung Busty, Ward No. 03, PS Pradhan Nagar, Dist. Darjeeling and (2) Rohit Singha (M/21) S/O Nakul Singha of Gurung Busty, Ward No. 03, PS Pradhan Nagar, Dist. Darjeeling, Sourav of Maynaguri, PS Maynaguri, Dist. Jalpaiguri and others under proper section of law and arrange for its investigation.
