Respected Sir,

I, **SRI. BISHNUPADA SAHA**, Son of Jiban Saha, Hindu by religion, business by occupation, resident of Champasari, P.O. & P.S. – Pradhan Nagar, District – Darjeeling, Pin - 734003, begs to inform you that I am a tenant under one Shri. Vinod Kumar Jaiswal, son of Rajendra Prasad Jaiswal, r/o J4, 12 Civil Township, Sundargarh, Rourkela, P.O & PS – Raghunath Pali, Dist – Sundargarh, Orisha, Pin – 769004, in his complex namely “JAISWAL COMPLEX”, situated at Mouza – Kalkut, recorded in LR kahtain no. 5655, corresponding to LR plot no. 159 and 307, JL no. 44, Pargana – Patharghata, PS – Pradhan Nagar, Dist – Darjeeling which was constructed by my landlord / owner i.e. Shri. Vinod Kumar Jaiswal and I was running my vegetable business from there.

That in the said Jaiswal Complex there are five shop rooms in the front side and three residential accommodations in the back side and I got shop room 1 to run my car wash business and I was using the said car wash peacefully and paying the rent regularly to the land landlord / owner i.e. Shri. Vinod Kumar Jaiswal.

That suddenly on 15/05/2023 in the morning at about 11.20 a.m. 1) Sri. Ram Sakha Singh, son of Late Bhogi @ Bhugani Singh, 2) Sri. Ajit Kumar Singh @ Rangila, son of Sri. Ram Sakha Singh Sardar 3) Sri. Biswajit Singh @ Azad, son of Ram Sakha Singh Sardar and 4) Smt. Monika Singh, daughter in law of Sri. Ram Sakha Singh Sardar, came to the said property along with 100 men and muscleman who are local goons of the locality and bring one bulldozer cum JCB, iron rods, kukris and sharp weapons and thereafter they abused me with filthy languages and told me to quit and vacate the premises with the demand that they are the owner of the property and also threatened me if I do not vacate the premises then they will kill me and then they started to hit me with iron rod, feast and blows and thereafter stole cash amounting Rs. 15,000/- from my cash drawer and thereafter also stole vegetable and fruit amounting Rs. 35,000/- and thereafter broke my fridge and all my table and light and fan in my shop room.

That when I raised objection they all grabbed me and tried to run over me by throwing me in front of a running traffic with intent to kill me but somehow I rescued myself and with the help of other tenant and other local people I was able to survive and thereafter I raised strong objection and resisted them from encroach the entire property by demolishing the structure with the help of a bulldozer cum JCB and then other tenant and local people raised objection they all

were compelled to leave the place but threatened me that if I don't follow their order then I have to face dire consequences.

That they said that if I do not vacate the place and resist them from taking forcible possession of the said property then they will not hesitate to kill me and my family.

That when I raised my strong objection with the help of our tenants and neighbors at that time they were compelled to leave the place but they again threatened me while leaving the place that if I do not vacate the place then they will not hesitate to kill me to take forcible possession of the land.

Sir, I am under constant fear for my life and this is my humble request to you that to take proper and strict legal action against this people.
