Sir, I Khurshed Ali, the above noted complainant
beg. to inform you that I was at E-Rikshaw (Toto) driver
and on 16.05.2023 at about 03:30 pm. When I was
standing at Bidhan Market, opposite Hankey Market
in search of passengers, at that time 02 (two) adult
women, who were with 03 (three) minor female children
approached me to go to Golden Plaza Market at
Burdwan Road, when they agreed on the fare fixed
by me, I took them all, but on the way these 03
(three) minor female children were continuously
crying, when I reached near Sovraj Hotel, Chana
Biddy, Ward No. 6, then the said adult passengers
held me to stop the E-Rikshaw where they will check-
in a Hotel with the children, on the way when
those 02 (two) adult females were talking among
themselves, I heard that they have planned to
go to Ladakh with these minor children. Now
that Sovraj Hotel one unknown 02 (two) individuals
came near my toto when he saw that the children
were crying, and told me to go to Siliguri Police
Station along with all therefore I brought them all
to Siliguri Police Station and I have come to the
conclusion that those 03 (three) minor female children
were kidnapped by those 02 (two) adult females,
whose names were later ascertained as (1) Toseung
Chanda & (2) Yasmin Malik, noted above, and were
taken to P.O & Distt- Loh (Ladakh), for the purpose best known
to them. So please take necessary action.
