Sub Written Complaint Cyber

Sir

I am Dr. Ramesh Shah (Micro Artist) , National Chairman International Human Right and Anti Crime Organization , Son of Late Mishrilal Shah , resident of Samar Nagar Colony (SMC) , Ward No.46 of S.M.C.P.O. Champasar , 734003 PS . Pradhan Nagar , Dist . Darjeeling beg to lodge this written complain against the opposite party Ankeet Sah (Mobile No 75760-17892) , Son of Dr. Ramesh Shah residing at Gauripur , Ward No.3 , P.O.Gauripur , Dist . Dhubri (Assam) . I beg to inform you that in the year 1996 my first wife Smt . Geeta devi had passed away . At that time my two daughter namely (1) Roshni Sah (aged 4 years) & (2) Ashwini Sah (aged 2 years) were there . Seeing the bad condition of me and two innocent girls , my family members fixed my marriage with one Anita Sah , divorcee daughter of Late Ram Kumar of Gauripur , Ward No 3 , P.O. Gauripur , Dist . Dhubri (Assam) and on 25.11.1997 I was married to Anita Sah . After few days of my marriage , Anita Sah started torturing my two minor daughters and after spending a few months , she left my house forever and went to her house at Gauripur at that time she was one month pregnant . On 09.01.1999 she gave birth a male baby named Ankeet Sah at Gauripur , Assam . One month later , with great difficulty , I got a chance to see the new born baby . After that my wife banned me from seeing the child . And he has not allowed me to meet my son till date.the matter also went on in the Court , presently my son Ankeet Sah's age is 24 years . Be it mentioned here that , myself and my daughters tried to contact Ankeet Sah on mobile phone from time to time but the sad aspect is that on last date 09.03.2023 me and my daughter tried to contact Ankeet Sah by mobile after that with rude language on 10.03.2023 Ankeet sent a message in dirty language about me and my late mother which is not possible for me to write in it . Not only this , Ankeet Sah has written such dirty things about me and my character which is unspeakable and not tolerable . Similarly , my elder daughter Roshni Sah had tried to contact Ankeet Sah on mobile thinking him as her brother and Ankeet Sah also sent her messages in dirty language and used words like bitch . I am giving all xerox copy with this complaint letter . Even before this Ankeet Sah has sent many messages in dirty language which have been deleted , from Whatsapp .

All these messages were sent by Ankit Sah from his mobile number +91 75760 17892 to my phone number 9064436228 and my daughter Roshni Sah's mobile number +91 82502 25006.

I know that his mother's hand is behind this , she has created a misconception about me to my son Ankeet Sah . Not only that Ankeet Sah again sent Whatsapp message on 02.04.2023 to my Whatsapp number and also call me in my mobile number by using obscene vulgar languages . By sending vulgar messages and calls opposite party make our lives unbearable . Due to his messages and tortures we may loss our lives . Please help us to survive in the earth . Finding no other alternative I came before you for your help and support a I am also a renowned painter . I have made India proud in the world by achieving five world records in Micro Art . In view of the special contribution in the social fields , I

have been awarded the doctorate by the New Jerusalem Medical College and Hospital , Vellore ,
Tamil Nadu . I have been

awarded with Banga Gaurav Samman , Bhumiputra Samman , Kanu Ratna Samman etc. by various
organizations . I had not thought that a son could use such foul language for his father late
grandmother and sister . And I am deeply hurt by his behaviour . It is a humble request to you that
taking this matter into cognizance , strict action should be taken against Ankit Shah . So that in
future he does not dare to does so again . Under the above circumstances , I would request you that
please investigate that matter and punish the opposite party named Ankeet Sah for his illegal act
and activities , which will create pressure upon the health and mind of me and my family members .
