Sir,

With due respect, I am producing herewith one arrested accused person namely Bishal Rai (32) S/O Mani Kr Rai of Pudung Basti, PS-Kalimpong, Dist-Kalimpong @ Derwali hotel, NJP hotel line, P.S- NJP, Dist- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 17 (Seventeen) bottles of Himalayan Fata Fati 70 UP country Spirit (each bottle containing 300 ml.)

I, ASI-Sajal Das presently attached with NJP PS under your kind control beg to state that today i.e. on 27.04.2023 at 23.35 hrs I received a secret source information that one person namely Bishal Rai is selling ID liquor illegally at his hotel Derwali at NJP hotel line, under NJP P.S. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No: 1224 date: 27.04.2023 and informed the fact to you. As per your kind direction and instruction myself along with VP/08 laxman Roy, CV/306 Biswajit Roy all of NJP PS, SPC left for NJP hotel line, PS- NJP, Dist.- Jalpaiguri to work out the information in hand. At 00.05 hrs we arrived at NJP hotel line, under New Jalpaiguri PS, Dist.- Jalpaiguri and being identified by the source I held raid the hotel where the above noted accused person selling ID Liquior . Accordingly as per the indication of Source I managed to apprehended him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his hotel since long for his illegal gain. On search the above noted I/D liquor recovered from his hotel. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his shop. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 00.15 hrs to 00.45 hrs on 28.04.2023

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Bishal Rai (32) S/O Mani Kr Rai of Pudung Basti, PS-Kalimpong, Dist-Kalimpong @ Derwali hotel, NJP hotel line, P.S- NJP, Dist- Jalpaiguri and arrange for its investigation.
