Sir,

Most humbly, I Rejesh Kumar Agarwal, S/O. Late Gulab Chand Agarwal, resident of SF Road, Maharaja, P.S. Siliguri, Dist. Darjeeling apprising you that I being the attorney of Binod Kumar Agarwal I filed a suit for declaration of title and injunction along with an application under order- 39 Rule I & 2 read with section 151 of C.P.C. and after hearing the Ld. Court was pleased to pass an order of injunction in the following manner:

Ordered

"That the prayer for an order of ad-interim injunction is allowed but in part;

That the defendants and their men and agents are hereby restrained from causing interference in the peaceful acts and possession of the plaintiff and forbidding them from encroaching any portion of the property forcibly till 17-01-2023". And the said order has been extended till 15-06-2023.

That the persons mentioned in the bottom of the FIR are land grabber and land mafia in the locality. They threaten me with dire consequence with the intent to grab the land inspite of having the order of injunction of the Ld. Civil Judge Junior Division (1 st), Jalpaiguri vide title suit No. 585 of 2022.

That today at about 10:00 A.M. the opponent party mentioned in the bottom of the FIR along with some antisocial persons of the locality have broken the fencing of my land and entered into the schedule land. After hearing the information I along with my well wishers went to the spot and on being protest they threaten us and used filthy language and fled away.

In the above premises I request you to look into the matter so that might is right shall not be prevailed over the rule of law and the solemn order of the judiciary may not be dishonoured.
