On 11/04/2023, time near about 9:15^{pm} to 9:30^{pm}
when I coming from my friends house at Gadadhar
Pally form dropping my friend. when I coming
Gadadgar pally road by waking them Dipen Barmam
seen to me and attack them Parakshit Barmam, Uttam
Roy and Prakshit wife hit me by punch and kick,
Uttam Roy hit me by kick to my several, each and
every body parts also hit my head by bar(^{as})
and Prakshit Barmam wife hit me by shove and
thrift my Gold Chain (15gm), and silver chain
(30gm) and pendent of Hanuman ji, and also
lose that time 50,000 Rupees for my worker
salary and also lose my Italian Sunglass
and Black commando Cap.

I have injured dangerously
Please seen my medical report which
are attached with this letter.

I hereby inform you that the incident
was totally pre planned for murder and
also robbery. I think that my gold
chain, silver chain and RS- 50,000 is in
hands of Uttam Roy, Praushit Barman, Dipen
Barman and Praushit wife.

Also inform you that my injury
details given on doctor's report so,
please check doctor report throughly
and sir right now I suffering
from left side back pain and left
side nose middle portion be inflated/swelling
also back side of head middle lower
portion to be inflated/swelling.

If you kindly allow to me
and accept my letter and giving proper
Justice to me then I will be very
greatfull to you.
