Ramnagachi, P.O- Madampur-Krishnapur, P.S- Madhyamgram  
Dist- 24 Parg(N), Kol- 700128,

On 11/04/2023, time near about 9:15 pm to 9:30 pm  
when I coming from my friend's house at Gadadhar  
Pally form drooping my friend. When I coming  
Gadadgar road by walking them Dipen Barman  
Seem to me and attack them Parakshit Barman, Uttam  
Roy and Parakshit wife hit me by punch and kick.  
Uttam Roy hit me by kick to my several, each and  
every body parts also hit my head by bar(fas)  
and Parakshit Barman wife hit me by shoe and  
threft my Gold Chain (15gm), and Silver Chain  
(30gm) and pendant of Hanuman ji, and also  
lose that time 50,000 Rupees for my worker  
salary and also lose my Itian Sunglass  
and Black Commando Cap.

I have injured dangerously  
Please seen my medical report which  
are attached with this letter.

I hereby inform you that the incident  
came to have pre planned for murder and  
also robbery. I think that my gold  
chain, silver chain and RS- 50,000/- is in  
hands of Uttam Roy, Pranshit Barman, Dipen  
Barman and Pranshit wife.

Also inform you that my injury  
details given on doctor's report so,  
please check doctor report thoroughly  
and sir right now I am suffering  
from left side back pain and left  
site nose middle portion be inflated/swelling  
also back site of head middle lower  
portion to be inflated/swelling.

If you kindly allow to me  
and accept my letter and giving proper  
justice to me then I will be very  
greatfull to you.
