Paraddut Sarkar, S/O - Late Madhab Chandra Sarkar, resident of Phola More, P.S. - N.T.P., Dist - Jalpaiguri, would like to inform you that: on 27.04.2023 at about 1:30 pm, while I was making a drain in my boundary, that time one my neighbor Sri. Sanjit Basman, S/O - Late Bhagan Basman, along with his two sons namely 1. Sri. Saratan Basman, & 2. Sri. Ajay Basman, all are residing in a baw house adjacent to my house, suddenly came to me and tried to prevent me to making such drain, without any reason. and also started to threatening me to stop the work. When I protested them for their unbridled demand they assaulted me with fist and blow, therefore my wife Smt. Maya Sarkar came to save me from them and suddenly said Sri. Saratan Basman beaten her-~~self~~ in her head with a bamboo with the intention to kill her and for that she got serious injured to her head and with the help of some wellwishes I saved her anyhow and then I took her in Diliguri District Hospital. Now she is under observation and admitted in yac yuvaan hospital.

In such a situation I am extremely helpless; therefore I request you to take immediate lawful

action in this regard.
