Bagdogra, District Darjeeling, Pin-734014, West Bengal, India, would like to state that I married **Sri Bhunesh Sah**, S/o. Late Baijnath Sah, R/o. Ho-Chi-Min Nagar, P.S. & P.S. Bagdogra, District Darjeeling, Pin-734014, West Bengal, India, in the year 2011 according Hindu rites and customs at Bhujiapani, P.O. & P.S. Bagdogra, District Darjeeling. At the time of marriage my husband assured me that he will keep me in good condition and will lead a happy married life. The marriage was consummated and I gave birth to a two (2) female child namely Chandni Sah aged about 10 years & Pushpa Sah aged about 2 years & 10 months. Everything was going good but the situation change after birth of my second daughter. I work as maid servant to earn my livelihood and my husband being a regular drunker always demands money from me. He snatches all my monthly income and miss-use the money in alcohol. If I don't give money then he quarrels with me and uses slang language and insult me in front of everyone. He even physically tortures me with hits & blow.

Ho-Chi-Min Nagar, P.S. & P.S. Bagdogra, District Darjeeling, Pin-734014, West Bengal, India. My Mother-In-Law **Smt. Champa Devi Sah** & Brother-In-Law **Sri Sarala Sah** both always get themselves involve in my household and physically tortures me. They always threatens me that if I stay in the matrimonial house then they will kill me either by putting kerosene oil or by hanging me. I & my daughters are in fear. All of them has put my & my both daughter's life in a miserable condition. I have two minor daughters and this stage of life I have no other place to reside.

It is prayed before you to kindly take necessary strict action against my husband **Smt. Shila Sah** and in-laws **Smt. Champa Devi Sah & Sri Sarala Sah**.
