- 7. That not only cheating me, he also assaulting me with wrong full languages with bad motive of body languages and also tried to assault me physically when I requested him to refund my amount of Rs 2,70,000/- (Two Lac Seventy Thousand) only.
- 8. That he also threaded me by saying that he is a dangerous person and not to force him to refund the said amount and any incident may occur at any time and he blocked my mobile number. His mobile No 9647787766.

9. That I came to know from the locality that he is a cheater and cheated many person and receiving the money in the name construction.

That I am very much afraid from him as his motive is not good and I am cheated by him.

So, I do hope that you would be kind enough to allow my prayer and investigate the matter in favour of me and take proper step.
