Respected Maam,

I, Smt. Rukshana Khatoon @ Ruksan Khatoon, W/o Subhan, presently residing at Jyoti Nagar Colony, Ward No. IV of SMC, Siliguri Dist Darjeeling, would like to state as follows:

- a) That I got married with one Subhan S/o Md. Akramul, resident of kanki bazaar P.O Kanki Dist. Uttar Dinajpur according to muslim rights and customs on 24.04.2019 and since our marriage I started residing with my said husband Md Subhan S/o Md. Akramul as husband and wife in our matrimonial home at Kanki Bazar, P.O. kanki, Dist: Uttar Dinajpur.
- b) That at the time of our marriage my father Md. Jamal gave Rs. 1,50,000/- (Rs. One Lakh Fifty Thosand) only as cash, two piece of gold chains, two gold ring, one gold earrings, one nose pin, one mangtika, set of gold bangles and some silver ornaments as per the demand of my husband and my father-in-law.
- c) That inspite of giving those articles as per their demands after a laps of few weeks of our marriage my husband namely Md. Subhan and his relatives namely 1) Shamin Qureshi, 2) Alim Qureshi, 3) Kalim Qureshi, 4) Sultan Qureshi, 5) Nasim Qureshi all sons of Akramul Haque, 6) Md. Sajis, all resident of Kanki Bazar, P.O. kanki, Dist: Uttar Dinajpur along with one 7) Nasima Qureshi, W/O Md Sajis 8) Mina Qureshi, W/O Kalim Qureshi 9) Akramul Haque, S/O Md Sultan, all resident of Kanki Bazar, P.O. kanki, Dist: Uttar Dinajpur, started pressuring me to ask for money from my parents and protesting for fulfilling their such demands started torturing me both mentally as well as physically and due to such physical torturer inflicted to me by them on several occasion I had to avail doctor treatment for my health.
- d) That my husband and his relatives are people with large political influence and as such they had threatened me that if I ever complaint about such torture to anyone else then I would face dire consequences as my parental home is far and no one would come to save me on time.
- e) That inspite of being abused from such mental and physical torture from my husband and his relatives, and knowing the fact that they have strong political connections in Kanki, I kept suffering such mental and physical torture from them thinking one day they will realize their mistake and my suffering will stop.
- f) That such mental and physical torture became so frequent that on 30.06.2020 was kicked out from my matrimonial home and being helpless I had to take refuge in my parents house at Siliguri.


- g) That I and my parents on several occasion visited my matrimonial home to request my husband and his family members to take me back but instead of doing such they insulted my family members and threatened that if we ever come back again to Kanki then we will have to suffer from dire consequences.
- h) That on 02.05.2023 I came to know from reliable source that my husband has married one Girl D/O Kutub Alam resident of Kanki, Naya Bazar P.O. Kanki, Dist. Uttar Dinajpur and at present they are living as husband and wife in my matrimonial home at Kanki Bazar, P.O. kanki, Dist: Uttar Dinajpur.
- i) That I along with my brother and my father went to Kanki Bazar, P.O. kanki, Dist: Uttar Dinajpur on 05/05/2023 and to my utter shock found that one Girl was living with my husband as his wife in my matrimonial home and on protesting it my husband 1) Subhan S/o Md. Akramul along with his family members 2) Shamin Qureshi, 3) Alim Qureshi, 4) Kalim Qureshi, 5) Sultan Qureshi, 6) Nasim Qureshi ~~with some of their kinsmen~~, 7) Md. Sajis, all resident of Kanki Bazar, P.O. kanki, Dist: Uttar and 8) Nasima Qureshi, 9) Akramul Haque Son of Md. Sultan, started abusing us in filthy and vulgar language and stated that if you ever come back again in Kanki Bazar, P.O. kanki, Dist: Uttar Dinajpur then they will kill me along with my family members as they have immense political influence in that area.

Mam now I am in apprehension that if I visit my matrimonial home then my life will be in danger and my husband and his relatives will use valuable jewellery and ornaments which I have left in Kanki Bazar, P.O. kanki, Dist: Uttar Dinajpur for their ulterior motives.

I, therefore, request you to take immediate strict necessary legal actions against my husband and his relatives and you to kindly look into this matter in accordance with law from your good office and urgent co-operation is very much expected in this regard.
