Sub:- Written complaint against 01(one) TOTO Driver of plying illegally on Hill cart Road without any valid documents causing obstruction to public way.

Sir,

I SI, Kedar pradhan of Panitanki Traffic Guard, SPC beg to lodge a written complaint that on 20.05.23 around 20.00 hrs, while on duty at Hill cart Road area found one (1)TOTO without any registration number stationed near Air view More in such a way blocking the free flow of traffic and causing hindrance and danger to the general public and other vehicles.

Accordingly I detained said TOTO and on being asked the driver disclosed his identity as Bibek Karmakar (24 Yrs), S/o- Sanjoy Karmakar of Arabinda pally ,w/no 22, P.s- siliguri Dist- Darjeeling. Further on being asked to produce relevant documents in support of his claim of plying TOTO on Major Road he failed to produce any valid documents. Thereafter I seized the TOTO and arrested the person under section 41 Cr. PC in c/w the case after observing all rules and formalities.

Therefore I would request you to kindly start a specific case against the above noted pers. (TOTO Driver) under proper section of law from your end.
