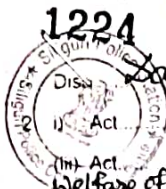

**Sub:- Complaint against my Daughter-In-Law namely SMT. SHILPI SARKAR for causing tremendous mental and physical torture upon me and my son and also for threatening us and using filthy and abusive languages towards us.**

Respected Sir,

With due respect I, **SMT. MAMATA SAHA**, Wife of Late Binay Saha, Resident of Raja Ram Mohan Roy Road, Hakim Para, Ward No. 12 of S.M.C., Siliguri, P.O. & P.S. Siliguri, Dist. Darjeeling, Pin: 734001, would like to lodge this Written Complaint to the effect that I am an old aged senior citizen (61 Years) and being a Senior Citizen, I have been suffering with severe old aged ailments since last few years.

Sir, Binay Saha (Since Deceased) is/was my legally married husband and out of our lawful wedlock, we have one son namely Sri Sanjay Saha and one daughter namely Smt. Susmita Saha and both are married now and since the date of marriage, my said married daughter has been residing at her matrimonial house with her husband Sri Anindra Majumder and other in laws members happily and peacefully.

Sir, my only son namely Sri Sanjay Saha is also married and his marriage was solemnized on 16.06.2022 with Smt. Shilpi Sarkar, Daughter of Sri Sunil Sarkar, of Bagrakot, Ward No. 20 of S.M.C., Siliguri, P.O. & P.S. Siliguri, Dist. Darjeeling. It is pertinent to mention here that the marriage of my son was a negotiated marriage and at the time of negotiation of his marriage, said Smt. Shilpi Sarkar and her family members told us that she was previously married with another person namely Sri Digendra Kumar Mitra, of 393, Lake Garden, Laskapur, P.S. Laskapur, Sonapur, Kolkata and out of their lawful wedlock, one male child was born and they have also stated that their said marriage has already been dissolved on their mutual consent but during that time, they did not show any paper with regard to their dissolvent of their said marriage and believing their said version to be true, we have also agreed to arrange the marriage of my son with said Shilpi Sarkar and accordingly, their marriage was solemnized according to the Hindu Rites and Customs after observing all formalities of Hindu Marriage.

After their marriage, they have started to live and cohabited together as husband and wife at my own house as mentioned aforesaid and I being the mother-in-law, always gave my proper love and respect to my said daughter-in-law in all aspects and there was no problem in our family and we used to maintain our daily life peacefully but it is very painful to mention here that after the marriage of my only son with said Smt. Shilpi Sarkar, the atmosphere of our house become obnoxious as my daughter-in-law is not at all happy with the small earnings of my son and she always shows her desire to maintain a luxurious

lifestyle outside the house though, it is very much within her knowledge as well as within the knowledge of her family members about our family status.

Sir, since after their marriage, I along with my son have found and noticed that my daughter-in-law is a lady of bad character and she did not hesitate to use slang and filthy languages towards me and my son and inspite of that, we used to give proper love and respect to her considering the future conjugal life of my son with a hope that in future she will definitely realize her own mistake and thereby, rectify themselves but all our hopes have gone in vain.

It is very painful to mention here after their marriage, we also came to know that said Shilpi Sarkar and her family members have made false statement before us about her previous marriage and at the time of her marriage with my son, she was the legally married wife of her previous husband and during that time, her previous marriage was subsisting but suppressing the said fact, she again entered into marriage with my son illegally and when we made protest against her, she also confessed that during pendency of her matrimonial suit for divorce, she entered into marriage with my son and when we along with our son informed the matter to her family members as to why, they have made such false statement before us, they did not pay any heed and on contrary, they flatly neglected the same and inspite of that we did not make any complaint against her before any authority considering the future conjugal life of my only son and my son stated to lead his conjugal life with said Shilpi Sarkar bypassing her said activities.

Thereafter, time and again, we found and noticed that our daughter-in-law became more furious day by day. She did not hesitate to threaten us with dire consequences and also abused us with filthy and slang languages and on contrary, she also threatened us to implicate us in a false criminal case as she knows the legal steps very well.

Sir, suddenly on 20.05.2023, my daughter-in-law started to quarrel with me and my son without any just cause and reason and also started to assault my son in my presence and when I tried to resist her, she did not bother to assault me also and also threatened us to ruin our life and property permanently by implicating us in a false criminal case and put us behind the Iron Bar for a considerable period and at about 07.00 P.M., she left our house with her all belongings without giving any intimation either to my son or to me and at the time of leaving our house, she again threatened us with dire consequences.

I, therefore, being a senior citizen, fervently requesting you to look into the matter properly and please take appropriate strong legal steps against my daughter-in-law namely Smt. Shilpi Sarkar, as per the provision of law so that we can live our remaining life peacefully and obliged thereby.
