That one "Nur Ali", S/O Late Asan Ali, and his son "Mahboob Alam", both resident of Village- Kamrangaguri, P.O. Satellite Township, P.S. N.J.P., Dist. Jalpaiguri, Pin- 734015 (W.B.), had been claiming to be the owner of the land measuring about 8.50 Katthas, situated within Mouza- Dabgram, J.L. No. 02, R.S. Sheet No. 18, L.R. Sheet No. 195, R.S.
