Sub: FIR/Written Complaint


Sir,

I, **SMT KAVITA AGARWAL** S/o Sri Pradeep Agarwal, resident of Denzong Cinema Road, Gangtok Sikkim, would like to lodge a FIR/Written Complaint stating as follows:

1. That I am the owner of a factory premise situated at Kanchan Bari, Bangla Basti, Fulbari.
2. That said factory premise is kept locked since last one year or more.
3. That today morning, I got a call from one of my well-wisher in the area informing that some irregular activities is being carried on in my said premise, soon after getting the said information I along with my well wishers immediately rushed to the spot and found that since last many days activities of **THEFT** is being going on in my said premise.
4. That on visiting the site I found that, lock of my main entrance is broken from inside, electric fire pump is missing, all major fire and electric wire & cable are missing, entire electrical setup including its parts and panel and motors are also missing, 1 number of air conditioner, air compressor pump, iron gates of all labour quarters (i.e. five in number), one number of iron gate of main entry in factory, GI/aluminium channel ceiling of all labour quarter, aluminium partition and doors, Fans, lights, cut-outs of main meter are also missing and many other which may be found in due course of time.
5. That on inspecting my premise, I even found that the said miscreants have being residing in my premise at nights since a bed with pillow in nicely setup in one of labour quarter with lot of water bottle and anti mosquito packs (agarbati), with 5-7 lighters.
6. That estimated loss incurred by me could be around 10 to 12 Lakhs though actual amount is yet to be calculated.

That considering the above, I humbly request your good self for taking immediate and protective steps.
