This is to inform you, I Smt. Pinki Debnath, Daughter of Lt. Chunilal Debnath, am a resident of Paul Para, College Para, Islampur, Uttar Dinajpur, Ph No.- 6297640067. That I was married to one Prantik Debnath @ Papai, Son of Jiban Krishna Debnath, permanent resident of Bibadi Sarani, Ward No. 35, Bhakti Nagar, Jalpaiguri, Ph No.- 9093375219/ 8388052984 on 3rd May, 2012 at our residence at Paul Para, College Para, Islampur, Uttar Dinajpur according to Hindu rites and customs. That me and my husband had been cohabiting in our abovementioned residence on rent which we occupied when my husband moved to Islampur. That all the cash, gold ornaments, and all other valuables that were offered as Stridhan at the time of our marriage are in the custody of my husband's family members at my matrimonial home. That from the very initial stage of our marriage I have been rigorously inflicted with physical and mental torture. That ever since our marriage, my husband and his family members regularly tortured and abused me and made strict demands of dowry from me and my family members, and threatened with dire consequences if the said demands were not fulfilled. That out of the said wedlock one baby was born, namely Sourik Debnath on 19th November, 2015 at Alam Nursing Home, Islampur, Uttar Dinajpur. That my husband had no responsibility whatsoever towards our marriage and was extremely reluctant to perform his marital duties and obligations and duties and obligations towards his baby. That he used to often return home intoxicated and vehemently tortured and physically assaulted me right in front of our baby boy with no regard. That my husband had illicit relations during the course of our marriage, and on 1st June, 2022 he moved out of our rented residential premises without giving any prior notice to me and maintained no contact whatsoever with me since then.
