Sir,

In producing herewith one accused person named Bhola Singh (38), S/O- Jaganath Singh of Coolie Para, Ward No. 01, PS Pradhan Nagar, Dist. Darjeeling under arrest along with following articles under proper seizure.

1. Total of 10 bottles of 60 UP Himalayan Gold country spirit containing 600 ml (Price tagged as 120/- and total of 06 litres) and One bottle containing 600 ml of 60 UP Himalayan Gold country spirit containing 600 ml (Price tagged as 120/-) taken randomly as sample for examination.

I ASI Manoj Kumar Roy of Pradhan Nagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one accused person named Bhola Singh (38), S/O- Jaganath Singh of Coolie Para, Ward No. 01, PS Pradhan Nagar, Dist. Darjeeling to the effect that today on 18.05.2022, while performing mobile van duty received a source information at around 16.15 hrs that one person named is selling liquor in a shop styled at Coolie Para under Pradhan Nagar Police Station without any valid license.


Accordingly, I informed the matter to the I/CPS and as per his kind direction I along with CV/242 Rakesh Mangar, CV/646 Baban Das and CV/992 Jagadish Biswas had been to Coolie Para under Pradhan Nagar PS to verify the veracity of source information. On reaching there and as identified by the source found that one person was selling and storing illicit distilled liquor at his shop. Subsequently, I along with my force cordoned the shop and was able to detain the above noted above person. Subsequently on being asked the apprehended person disclosed his name and identity as noted above and stated that he is the owner of the shop. Further being searched the above noted seized articles were found in the said shop. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last 06 (six) months for his illegal gain. Then I seized and labeled the above mentioned illegal illicit distilled liquor under proper seizure and arrested the above-mentioned person named Bhola Singh (38), S/O- Jaganath Singh of Coolie Para, Ward No. 01, PS Pradhan Nagar, Dist. Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 17.05 hrs to 17.50 hrs at the spot and arrested him after informing the ground of arrest.


