I'm writing to report an instance of domestic abuse I've experienced as a First Information Report (FIR). I need your help in dealing with this situation and making sure my family and I are secure and okay.

The numerous incidents of physical abuse, verbal abuse, emotional abuse, economic abuse committed by my Husband on Me are as described hereunder:

On November 21, 2022, at my home, Sourav Chatterjee and I were legally wed using Hindu rituals and rites. Due to my husband, I have endured physical and mental abuse, anguish, powerlessness, and sadness for the past six months. Finally, I'm left penniless and compelled to submit the current case because I am unable to handle the pain and agony and I am frightened for my life.

- a) I had a love cum arranged marriage with Sourav Chatterjee. We come from different backgrounds I belonged to a closely knit family with a lot of family values and culture on the other hand my husband is working as a salesman in pharmacy which is driven only by money and materialistic gain.
- b) The time of marriage I was made to be believed that My Husband where a very well to do family. A lavish wedding was held at My residence by my parents and all the demands of my husband's family regarding jewelry, household items and other items for them were met by my parents, however my husband's parents and himself was not happy with the jewelry and household items and would constantly taunt and insult me and my parents for not getting jewelry and household items.
- c) Soon after the marriage I realized that my husband (Sourav Chatterjee) was very aggressive and angry and wanted to control me in every aspect. I was not given any space or freedom to do anything in the house apart from cleaning and cooking food and was specially told me that I cannot go out of the house or do a job which I found very difficult to deal with but owing to the values given to me by my parents, I always made every effort to deal with the miserable situation and kept quiet for the Peace of Mind of my parents. I had no other choice but to give myself totally to my husband and his family and mold myself according to their ways, which was very difficult from my side of the family.
- d) That after the marriage I tried to adjust in the matrimonial home at Naogaoan but my husband started abusing and taunting and beating me for being insufficient dowry in marriage that day I become victim of domestic violence harassment and exploitation and has been subjected to cruelty by My Husband.
- e) My husband is in the habit of taking alcohol and pills every day, and continuously harasses me daily.
- f) I have been brutally bitten by the stick, hand, and legs by my husband on the instigation forward the fulfillment of the demand of dowry. My Husband committed more cruelties on me so that I could bring money from my family however I bore all these sufferings because of the respect of my family.
- g) That on 24th November 2022, there was a function at my husband's home, and he was in a state of heavy intoxication, in front of all the guest he started insulting me stating that "you are nothing in this house you are just a maid for us" my husband has also spoken about my character in front of all the guests. After the guest left with all this drama, He started pulling hair and dragged me close the bedroom and started kicking and slapping me with all the verbal abuse.

- h) On 8 December 2022, my husband threw me out of the house after beating me brutally with hand and pulling my hair and abusing roughly. Around 3:00 AM When I shouted from outside of the house that I'm calling police then his mom came out and took me inside the house and told me everything will be OK in the morning, he will not remember all this stuff, do not call police do such things as it will hamper the integrity and respect of your family.
- i) On 17-January 2023, my husband started drinking alcohol since morning and taking weed, creating a mess at home Started peeing inside bedroom and told me to clean up the mess as it is my responsibility to take care as a maid. In the evening there was a marriage function and he wanted to go to the function he ordered me to get ready along with her sister, while he started passing comments "why you are getting ready do you want to see other man there ". Also commented on my mother stating, "your mom does not have any man in his life". Anyhow after all this drama I and my husband along with his sister went to a wedding function, there he again started drinking alcohol and lost consciousness in front of 200 guests. All the relatives requested me to take him home as he is drunk. There were four people who were trying to help him, but he again started abusing them using my name. Also, he started abusing me in front of everyone, somehow, we managed to take him home.
- j) On 8 February 2023, my husband was heavily intoxicated around 8:00 PM he again started abusing and threatened To KILL me and started hitting with bare hand and I was suffering from heavy Nosebleed. In the state of physical pain an extreme fear of finding no way out I called my family member for the first time to inform all the torture that I was going through on my day-to-day life.
- k) On 10<sup>th</sup> February 2023, my younger brother came to take me back to parent's home, however my husband started misbehaving with my brother threatened to kill all of us if my brother takes me back. Still, I left with my brother immediately as I was not able to bear the torture anymore.
- l) I am a lady under fear, threat, torture, and insecurity and has no means for this survival and maintenance of myself as completely a housewife. Under such circumstances I have been compelled to move here and there seeking financial support from my family members.
- m) On 21<sup>st</sup> April 2023, my husband came to Siliguri and called me from railway station and asked me to come to station to pick him up as he is drunk and not able to walk properly, he told me that he wanted to say sorry for his behaviour that's why he came to Siliguri, the time was around 12.30 am midnight. I told him that I cannot come as it's too late I will send my brother to pick you up so that we can talk at home in a peace way. After he reached near my parents building he called me again and told me to come down from the building as he wanted to speak to me in private. Without thinking anything I went down to meet him, when he saw me he littered slapped me and hold my hand so hard and started abusing me stating that " did you came here to meet other man" " why did u left with your brother when I said I will kill you if u leave my home". He was hurting me so much

that I had to call my younger brother and mother and when they come to control the situation my mother requested my husband to come up and talk to her face to face and tell her the reason why he is doing such behavior. After requesting so many times then my husband went up to the room, then he started abusing me and try to beat me then somehow my younger brother took him and take him to another room and told him to sleep now and what ever is the matter speak in morning. Then in the morning when my husband wake up he apologize me and told me that he will not do all this again and wanted to take me back then after all the discussion He took me back on the next day which is 22nd April 2022 morning itself

- n) I thought that everything would be back to normal again as he said he will not do such shameful things anymore he also mentioned that he will not beat me anymore. However, the same goes daily, he again drank alcohol every day and started beating me every now and then. My mother-in-law thought to send us on vacation to sort things out between us,

- o) I and my husband went to a resort by bike. The details of the recent incident are described below.

Incident Details: I and my husband went to resort with his own bike and reached there by evening 5PM, he also stocked up his alcohol and once we reached there he started drinking alcohol, around 9PM he started abusing me and my family member, when the things got out of hand my husband started beating me with his hand and started kicking me, I somehow managed to call my family members and inform that my husband will kill me tonight if he has not been stopped, on the background he was commenting "call your brother no one can save you tonight" my family member tried very hard to contact police but no one was receiving the call, they in fact called my in-laws house and informed them that to contact nearest police station as my husband will kill me tonight. My elder sister called the resort owner and told them to go and check or else she will die and if anything happens to her the resort will be responsible, with all this the owner of the resort and his wife went and separated me and my husband and they were shocked to see my face was swell due to beating. They have also requested not to call police as it will hamper the image of the resort. The guests were also complaining about the same of the resort. In the morning around 10 am I left the resort under protection with family members and went directly to Guwahati to stay at a relative's house. And after a few days I went to my parents' home.

3. Request for Immediate Action: I kindly request you to take immediate action on this matter and initiate an investigation into the domestic violence I have endured. It is crucial to ensure the safety and well-being of myself and my family. I am willing to cooperate fully with the investigation and provide any additional information or evidence required.

4. Protection and Legal Assistance: I also request appropriate protection measures for myself and my family, including restraining orders, if necessary. Furthermore, I would appreciate guidance and information on available legal assistance and support services for victims of domestic violence.

I trust that you will handle this matter with the utmost sensitivity and urgency. I look forward to your prompt response and action in this regard.
