Darjeeling, do hereby begs to state that I had a love & affairs with one Kaushik Paul, Son of Pradip Paul, resident of Hyderpara, Shivrampally, P.O. - Hyderpara, P.S. Bhaktinagar Dist, Jalpaiguri, for 10-11 months and thereafter I married with Kaushik Paul on 20.10.2020 as per Hindu Rites & customs at Ektisal Kali Mandir. That after marriage we began to start our marital life on a rented house with my in -laws at my above mentioned matrimonial house. That soon after the marriage after 4-5 months later my husband. Kaushik Paul started torturing meboth physically & mentally on simple family matters. That the said Kaushik Paul is a habitual drunker and on every night he used to come home at late night and torture me for doing job and earn money for him even my father in law and my Mother in law also torture me and they asked for dowry and they demanded a sum of Rs.1,50,000/- (One Lakh fifty thousand) only from my father and when I denied my husband and In laws increase their torture which is unbearable but in the main time I got pregnant and I used to such type of torture for the shake of my future life and my husband and Father in law and mother in law (Kaushik Paul , Pradip Paul and Champa Paul) are force fully signed me a loan agreement with State Bank of India, Hyderpara Branch and took financial help from the said bank in my name and used the said money in their personal purpose but as per their demand my father finally tried to help us and he assist to purchased a Scooty

in my name and now the said scooty is in possession with my husband. That my husband also used to bring his friends at rented house to make party. That out of the wedlock we have a male child namely, Soumyadeep Paul bron on 25.01,2023.

That thereafter on 22,05,2023 when I protested against my husband, Kaushik Paul for doing such illegal acts, he assaulted me mercilessly and I somehow ran away from my matrimonial house and saved.

That on the same day I visited at Bhakti Nagar Police Station and informed the matter before the duty officer for lodging complaint and he advised me for first make treatment myself and thereafter lodge a complaint against my husband and in laws and as per his advise finding no other alternative I took shelter in my father house and with the help of my mother I went to Bagdogra Primary Health Centre for treatment.

That at present I am residing at my father's house and the said Kaushik Paul is continuously threatening me on phone that he shall throw ACID on me. That the said Kaushik Paul is dangerous in nature and character and I am very much afraid that he shall harm me and my family.
