Sir,

In producing herewith one arrested accused person namely I-Bikash Chhetri (M/35yrs) S/O- Lt Nanda Kumar Chhetri of Salugara BSF road, P.O- Salugara, P.S-Bhaktinagar, Dist- Jalpaiguri along with following articles under proper seizure list-

- 1) 12 (Twelve) bottles of tuborg strong beer (each bottle containing 650 ml)
- 2) 06 (Six) bottles of Royal Blue Premium Whiskey (each bottle containing 750 ml)
- 3) 05 (Five) bottles of Old Monk Delux Rum (each bottle containing 750 ml)
- 4) 02 (Two) bottles of Officer Choice Whiskey (each bottle containing 750 ml)

I, PSI Koushik Raha S/O- Jitendra Raha of Bhaktinagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one namely I-Bikash Chhetri (M/35yrs) S/O- Lt Nanda Kumar Chhetri of Salugara BSF road, P.O- Salugara, P.S- Bhaktinagar, Dist- Jalpaiguri to the effect that today on 23.05.2023 at 15:10 hrs while performing evening patrolling duty, received a source information that one person namely Bikash Chhetri (M/35yrs) is selling liquor in his house at Salugara BSF road, under Bhaktinagar PS, without any valid license. Accordingly I informed the matter to the I/C Bhakti Nagar PS PSI and as per his kind direction myself along with force- C/915 Chandra Prakash Adhikary, C/1431 Dilip Barman had been to Salugara BSF road, under Bhaktinagar PS to verify the veracity of the information. On reaching there and as identified by the source I along with my force cordoned the area and able to detain the above noted person. Subsequently on being asked the apprehended person disclosed his name and identity as noted above and stated that he is the owner of the house. Further being searched the above noted seized articles were found in the said house. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last 06 (six) months for his illegal gain. Then I seized the above mentioned illegal illicit distilled liquor under proper seizure list in presence of independent witnesses and arrested the above mentioned person named I-Bikash Chhetri (M/35yrs) S/O- Lt Nanda Kumar Chhetri of Salugara BSF road, P.O- Salugara, P.S- Bhaktinagar, Dist- Jalpaiguri U/S 41 Cr. P.C after observing all sorts of formalities at the spot. The whole process of seizure has been made in between 15:55 hrs to 16:35 hrs at the spot and arrested him after informing the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against I-Bikash Chhetri (M/35yrs) S/O- Lt Nanda Kumar Chhetri of Salugara BSF road, P.O- Salugara, P.S- Bhaktinagar, Dist- Jalpaiguri under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
