I SI Biswajit Sarkar S/O- Lt. Joydeb Sarkar of Siliguri P.S under Siliguri Police Commissionerate do here by lodged the complaint to the effect that on 23-05-2023 while performing Special van duty receive source information that one person has been selling/storing huge quantity of fire crackers/fireworks at his shop styled as Sanjay stationeries at Bidhan market under Siliguri PS. Accordingly I informed the information to I/C Siliguri PS and as per order by I/C Siliguri P.S vide Siliguri P.S GDE no-1469 Dated: 23.05.2023 myself along with ASI Subir Sen, ASI Debasish Das, CV-283 Prasenjit Dey, Cv-622 Ramanath Barman conducted raid against selling/storing of fire crackers/fireworks at the shop of Monotosh Sarkar styled as Sanjay stationeries at Bidhan Market under Siliguri PS as there was secret source information that he had been selling/storing fire crackers/fireworks of beyond permissible sound limit illegally.

During raid apprehended one person who on being asked identified himself as noted above and found him possessing above noted seized fire crackers which was kept concealed at his shop. On being asked Monotosh Sarkar admitted his guilt of purchasing, storing and selling of fire crackers at this Shop without license. He also could not produce any documents in respect of huge quantity of those fire crackers. The fire crackers were kept and stored without any precautionary and safety measure at this shop. The said stored fire crackers are combustible in nature and endanger to human life and property. So, I seized the fire crackers under proper seizure list duly signed by the witnesses. The total quantity of Fire crackers/ fireworks is Fifteen (15) kgs approx total value amounting to Rs 16380/- approx. Accordingly, I arrested the above noted person u/s 41 Cr.P.C and acknowledge to the accused person. The seizure was made in between 19:10 hrs to 19:45 hrs.

Hence, I pray before you that a specific case may kindly be started against the person Monotosh Sarkar (54 yrs) S/o-Lt. Netai Chandra Sarkar of Haider Para 120/6 Ward no-39, PS- Bhaktinagar Dist- Jalpaiguri under proper section of law and arrange for its investigation.
