I Gur Nihal Singh, S/O Late Gur Mukh Singh, Resident of C-1007, Indira Nagar,
Lucknow-226016.

I beg to inform you that on 25-05-2023 at about in between 1 PM to 1:45 PM myself
along with Avinash Singh and Parmeshawar Singh as well as a Police team from Matigara P.S. visited
my land in measuring 23.23 acre situated at Mouza Panchkalguri, and found that some local young
people assemble at my land, I asked them why you are working or digging on my land I demand then
to produce any valid documents in respect of this land but they did not produce any valid documents
in respect of land and treat us very rudely. They start heated arguments and there were few
instances where they tried to man handled us but due to presence of police officers they get
controlled.

They stated that they are staff of land mafia Rahul Burman alias Shambhu
and Bijoy Saha and they threaten on our life.

Rahul Barman alias Shambhu and Bijoy Saha both make fake
document in respect of my land and selling it to different people of other states.
