In producing herewith one arrested accused person namely Sahajmal (29) S/o Atul of Baghmara, Thakurganj, Ward No. 7 PS Thakurganj, Dist. Kishanganj, Bihar along with following seized articles viz,

- (i) One transparent zipper plastic packet containing 302 grms (Three hundred two) said to be brown sugar (Heroin) Marked as "Exhibit -A" from which taken 10 grms said to be brown Sugar ( Heroin) as sample for examination and marked as "Exhibit-A-1".
- (ii) One electronic pocket scale weighing machine, black colour and style as Notebook.
- (iii) One Apple i-phone, IMEI 355325322708365, IMEI2- 355325322647878, MEID-35532532270836 and Sim No. 9547643934.
- (iv) One android mobile model Redmi , IMEI No. 867972055969838/22, IMEI2-867972055969846/22 and Sim No. 9801114734.
- (v) 16 (Sixteen) pics Indian currency note in the denomination of Rs. 500/- total amounting of Rs. 8,000/- (eight thousands).
- (vi) One Black colour Vehicle having No. WB-74-BM-2179 , model - XUV-300 ( Mohindra).

I, SI Sibdhan Karmakar S/O- Late Birendra Nath Karmakar of Bagdogra P.S , Siliguri Police Commissionerate do here by lodged this complaint against the above noted accused person to the effect that on 24.05.23 at 16-25 hrs received a secret source information that one person is going towards Naxalbari side with black colour XUV car with a strong reason to believe that he is carrying huge quantity of brown sugar in order to clandestinely dispose the same in Siliguri and Naxalbari area for his wrongful gain. The matter was diarized vide Bagdogra Ps GDE No- 1209 dt- 24.05.23. Accordingly, I informed the matter to O.C, Bagdogra PS as per his instruction myself along with SI Debabrata Khan, SI Binup Mahato, PSI Amit Saiba, C/851 Chandan Debnath, VP-01 Anselam kujur, CV-375 Jogesh Barman, CV-386 kishor Ranjan Hawlader, CV-389 Janak Singha left for the spot at 16-35 hrs to verify the veracity of the information vide corresponding Bagdogra PS G.D.E. No. 1210 dtd 24.05.23 and Bagdogra PS M.C.C No-2312/23 Dt.24.05.23.

At the time of departure from Police Station I bring spring weighing clock, small balance with stone, envelope, paper, sealing wax, gum, seal etc. On way to Kestopur More I called two independent witnesses namely 1. Md Islam (34) S/o Md Faruque of Halalbusty, Kestopur PS Bagdogra Dist. Darjeeling and 2. Raj kumar Das (35) S/o Lt. Prabhu Nath Das of Gournabusty, Kestopur, PS Bagdogra Dist. Darjeeling and make them aware about the information in hand and requested them to accompany with us as witness during the search and seizure if necessary. At about 16-55 hrs we arrived at Kestopur More by Govt. vehicle and started Spl. Naka checking to upcoming all the black colour vehicle and on identified by the source we gave signal to stop one Black colour vehicle, but on seeing police party said vehicle try to flee away from there but somehow we managed to detain the said vehicle bearing No. WB-74-BM-2179 and apprehended the above noted accused person on AH-02 near Kestopur More under Bagdogra PS with a strong reason to believe that he is carrying brown sugar and the apprehended person was found inside the vehicle on driving seat. On being asked he disclosed his identity as noted above which is not verified. I asked him to produce his identity proof documents, but he failed. After disclosing our identity I gave him option in writing to be searched in presence of an Executive Magistrate or by any Gazette Officer, upon which he agreed to be searched in presence of any one of the above. Accordingly I informed the matter to O.C. Bagdogra PS and he informed me over mobile phone to send one requisition to Sri Narendra Kalicotay, ACP, (SB), SPC as he is detailed Spl. Executive Magistrate for today. Accordingly I informed to Sri Narendra Kalicotay, ACP, (SB), SPC and requested him to come at the spot through one C/851 Chandan Debnath. At about 17-45 hrs Sri Narendra Kalicotay, ACP, (SB), SPC and O.C. Bagdogra
