Sir,

I, SMT. POOJA SHA, Wife of Sri Rajib Shah, daughter of daughter of Triloky Sha, aged about 25 years, Hindu by religion, housewife by occupation at present residing at Subhas Pally, Airport more, Bagdogra ,P.O & P.S Bagdogra, Dist. Darjeeling, do hereby begs to state that I had married with one Rajib Shah, Son of Sri Arjun Sha, resident of M.G Road, Near Star Cinema, Jaigaon, P.O. & P.S. Jaigaon Dist. Alipurduar, on 29.11.2017 as per Hindu Rites & customs at Hanuman Mandir, Jaigaon, Alippurduar . That at the time of social marriage, my father gave many valuable articles like gold ornaments, furniture, fixtures, clothing, Washing Machine, LCD, Showcase, Wooden Dining Table, Almirah etc. and other valuable articles were given by my father and my nearest relatives which are like "Stridhan Properties" that all are kept with my husband .That after marriage we began to start our marital life with my in -laws at my above mentioned matrimonial house. That soon after the marriage after 4-5 months later my husband, Rajib Shah started torturing me both physically & mentally on simple family matters. That the said Rajib Shah is a habitual drunkard and on every night he used to come home at late night and torture me for doing job and earn money for him even my father in law and my Mother in law also torture me and they asked for dowry and they demanded a sum of Rs.2,00,000/- (rupees Two Lakh) only from my father and when I denied my husband and In laws increase their torture which is unbearable but in the main time I got pregnant and I used to such type of torture for the sake of my future life and my husband and Father in law and mother in law (Rajib Shah , Arjun Sha and Pramila Sha) are force fully started restraining the Petitioner from going outside the house and was detained and was denied to socialize with other people in the area. That my husband also used to bring his friends at matrimonial house to make party.

That thereafter on 23.03.2023 he came at Bagdogra at my father's house and assaulted me with a simple matter and threatened me and my father and mother with dire consequences ,when I protested against my husband, Rajib Shah for doing such illegal acts, again he assaulted me mercilessly and I somehow save myself and saved my minor child.

That on the same day I visited at Bagdogra Hospital and asked my father and mother for lodging complaint and they advised me for first make a treatment yourself and thereafter lodge a complaint against my husband and in laws then as per the advised of my parents finding no other alternative I took shelter in my father house and with the help of my mother I went to Bagdogra Primary Health Centre for treatment and again and again 02.05.2023 my husband came at Siliguri and threatened me over telephone for kidnap my daughter.

That at present I am residing at my father's house and last 5 days said Rajib Shah is continuously threatening me on phone that he will kill me by sending "Supari killer" and kidnap my minor daughter from my custody. That the said Rajib Shah is dangerous in nature and character and I am very much afraid that he shall harm me and my family.

Sir, I therefore request you to look into the matter and take necessary legal action against the said Rajib Shah and his father and Mother and punish them according to law for the ends of Justice.
