Sub: - Written complaint against 01(one) TOTO Driver plying illegally at Kachari Road  
(Hospital More) without any valid documents causing obstruction to public way.

Sir,

I ASI, Rajat Kr. Saha of Panitanki Traffic Guard, SPC beg to lodge a written complaint th...  
on 27.05.23 around 15.05 hrs, while on duty at Hospital More area found one TOTO without any  
registration number stationed near Hospital More in such a way blocking the free flow of traffic  
and causing hindrance and danger to the general public and other vehicles.

Accordingly I detained said TOTO and on being asked the driver disclosed his identity as  
Ranjit Barman (25 Yrs), S/O- Rajendra Barman of Fokdoibari, Ashigarh, PS-Bhakti nagar, Dist-  
Jalpaiguri. Further on being asked to produce relevant documents in support of his claim of  
plying TOTO on Major Road he failed to produce any valid documents. Thereafter I seized the  
TOTO and arrested the person under section 41 Cr. PC in c/w the case after observing all rules  
and formalities.

Therefore I would request you to kindly start a specific case against the above noted  
person (TOTO Driver) under proper section of law from your end.
