In producing herewith arrested accused namely (i) Manotosh Roy (35 yrs/M) S/o- Lt. Mangla Roy of Madan Mohan Para, PS- Dinhata, Dist- Coochbehar A/P- Tikiapara Matangini-I, W/no- 28, PS-Siliguri, Dist- Darjeeling arrested u/s- 41 Cr.P.C along with following seized articles viz:

- i) Thirteen (13) Bottles Sealed Himalayan Gold premium 60 Up Country Spirit each containing 600 MI each labeled as Himalayan Endeavour PVT Ltd. Siliguri, West Bengal @ Rs 120 each(Amounting of Rs. 120/-*13=Rs 1560/-), in which one sealed bottle has taken from mother packet box as sample under proper seizure list, labeling and memo of arrest.
 - ii) One White Colour nylon bag.
- I, SI Biswajit Sarkar of Siliguri PS, Siliguri Police Commissionerate do hereby lodge this written complaint against the accused person namely Manotosh Roy (35 yrs/M) S/o- Lt. Mangla Roy of Madan Mohan Para, PS- Dinhata, Dist- Coochbehar A/P- Tikiapara Matangini-I, W/no- 28, PS- Siliguri, Dist- Darjeeling to the effect that on 27.05.23 at 19:30 hrs received secret source information that the above noted accused person carrying huge quantity of illicit liquor on a white colour nylon bag to sell the same under Siliguri PS area. Accordingly I informed the fact to IC Siliguri PS and as per his direction I along with SI Basudeb Guha, ASI Subir Sen, ASI Debasish Das and forces left for Hopital More under Siliguri PS vide Siliguri PS GDE no- 1720 dated 27/05/23. On reaching at 19:40 hrs there and as identified by the source cordoned the above noted area where he was selling illegal alcohol. On seeing the police party the above noted person tried to escape from the spot but we manage to apprehend the above noted accused person and on interrogation he disclosed his identity as noted above. On being asked he stated that he used to sale the 60 up country Spirit to locality without any valid documents as he violated the norms of Bengal Excise Act for selling the said Liquor without any valid License. On search Thirteen (13) Bottles Sealed · Himalayan Gold premium 60 Up Country Spirit each containing 600 Ml each labeled as Himalayan Endeavour PVT Ltd. Siliguri, West Bengal @ Rs 120 each (Amounting of Rs. 120/-*13=Rs 1560/-) in which one sealed bottle has taken from mother packet box as sample as per seizure list which was kept concealed in a bag. On being interrogation he could not produce any valid documents in respect of said liquor. He also stated that he is doing this Liquor business since long for his wrongful gain. Accordingly I seized the same in presence of witness duly signed by the witnesses. The seizure and label was made in between 19:55 hrs to 20:25 hrs. As such I arrested him U/S- 41 Cr.P.C after observing all legal formalities.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused Manotosh Roy (35 yrs/M) S/O- Lt. Mangla Roy of Madan Mohan Para, PS- Dinhata, Dist- Coochbehar A/P- Tikiapara Matangini-I, W/no- 28, PS- Siliguri, Dist- Darjeeling along with seized articles under proper section of law and arrange for its investigation.
