Sir,

In producing herewith one accused person named Deepak Mahato (32), S/O Shankar Mahato of Dagapur near Lokenath Mandir, PS Pradhan Nagar, Dist. Darjeeling under arrest along with following articles under proper seizure.

Total of 12 bottles of King Fisher Strong Beer containing 650 ml (Price tagged as 125/- and total of 7.8 liters) and One bottle containing 650 ml of King Fisher Strong Beer containing 650 ml (Price tagged as 125/-) taken randomly as sample for examination.

I, SI Abhishek Theengh of Pradhan Nagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one accused person named Deepak Mahato (32), S/O Shankar Mahato of Dagapur near Lokenath Mandir, PS Pradhan Nagar, Dist. Darjeeling to the effect that today on 28.05.2022, while performing mobile van duty received a source information at around 14.15 hrs. that one person named is selling liquor in a shop styled as Bikash Hotel at Dagapur near Lokenath Mandir under Pradhan Nagar Police Station without any valid license.

Accordingly, I informed the matter to the I/C PS and as per his kind direction I along with CV/646 Baban Das, CV/242 Rakesh Mangar, CV/992 Jagadish Biswas had been to Dagapur near Lokenath Mandir under Pradhan Nagar PS to verify the veracity of source information. On reaching there and as identified by the source found that one person was selling and storing illicit distilled liquor at his shop styled as 'Bikash Hotel'.

Subsequently, I along with my force cordoned the shop and was able to detain the above noted above person. Subsequently on being asked the apprehended person disclosed his name and identity as noted above and stated that he is the owner of the shop styled as Bikash Hotel. Further being searched the above noted seized articles were found in the said shop. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last 06 (six) months for his illegal gain. Then I seized and labeled the above mentioned illegal illicit distilled liquor under proper seizure and arrested the above-mentioned person named Deepak Mahato (32), S/O Shankar Mahato of Dagapur near Lokenath Mandir, PS Pradhan Nagar, Dist. Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 16:30 hrs to 17:05 hrs at the spot and arrested him after informing the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Deepak Mahato (32), S/O Shankar Mahato of Dagapur near Lokenath Mandir, PS Pradhan Nagar, Dist. Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
