Subject: FIR against my husband and in-laws

Sir,

Myself, Smt. Manorama Singh Barman, daughter of Shri Tapan Singh Barman of Flat number N/2, 2nd floor, Ashiyana Apartment, Matigara, Darjeeling District got married with Sri Amit Naskar, son of Shri Dilip Kumar Naskar of Panchpota, Near Badan Chandra Indumati High School, South 24 Parganas, P.S: Garia 700152, West Bengal as per Hindu rites and customs on 25th January 2019.

I met my husband through shaadi.com. He had sent me a proposal for marriage, followed by visit of my parental house by his parents and relatives. All seemed well until the negotiation of marriage was finalised but since the very day of marriage they started demanding furniture, household goods and dowry.

The quantum of torture started aggravating gradually. My husband even started abusing me physically, mentally & emotionally. My husband used to indulge in extramarital affair with other women and whenever I raised protest, I was subjected to physical & mental torture. He was supported by his parents and his sister Barnali Naskar Mondal too. My husband & my in-laws insulted, disrespected & humiliated me every now and then, whenever I protested against my husband's extra-marital affair which they had kept hidden from my knowledge.

On 13th August 2019, I was sent to my parental house on the pretext of performing Bhadra month ritual. All my streedhan articles and valuable belongings were kept at my matrimonial home. Neither my husband nor any of his relative made contact with me for my return back to my matrimonial home. When I contacted during the end of Bhadra month (2nd week of September, 2019) I was asked by my father-in-law & mother-in-law not to return back to their son's house and life. I was totally devastated, shattered and had nowhere to go rather than taking shelter from my parents. With the hope of reformation in the behaviour of my husband and his family towards me, I awaited for their call every

passing day. However, time could not bring any change in their attitude towards me. They abandoned all ties with me by not contacting me nor responded my phone calls. Unfortunately, few months later the Covid pandemic also literally hit hard on my life. My husband and my in-laws have retained all my streedhan articles and have been misusing & misappropriating them for their own use. Recently, I have come to know that my husband has brought one lady, namely Pramila Biswas as his wife since 17th January 2023. My husband Amit Naskar & Pramila Biswas has totally ruined my life.

Due to such mental and physical torture upon me at the hands of my husband, his parents and sister, I have been mentally shattered and I am compelled to spend days in distress. At times, I even feel like committing suicide due to such behaviour of my husband & in-laws.

Therefore, I humbly request you to register this complaint as FIR and may the culprits be punished as per law. Please help me in getting justice.
