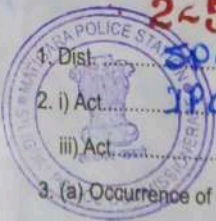

Sir,

I, GABAI DEBNATH, son of Lt. Atul Debnath, resident of Vill. Kawakhali Bazar, P.O. Sushratanagar, P.S. Maligara, Dist. Darjeeling, would like to inform you that one Dhiren Roy, son of Unknown, is one of our villager. He has a vegetable shop which is maintained and run by his son-in-law namely SANTO BISWAS, son of Unknown and said Dhiren Roy also sells local spirit/alcohol from his house illegally. Yesterday 26.05.2023 at about 8:30 P.M., my mother went to the aforesaid vegetable shop to buy food vegetable worth Rs. 40/- and gave him Rs. 200/- but said SANTO BISWAS denied and refused to return Rs. 160/- saying that my mother gave him Rs. 100/-, but my mother denied his contention.

Suddenly ① SARALA Roy, w/o. Dhiren Roy (his mother-in-law), ② RINKI Roy, d/o. Dhiren Roy (his sister-in-law), ③ ANANON, Roy w/o. Santo Biswas (his wife) viciously started to assault her with fists and bamboos with an attempt to kill her, in her body and head as a result she is severely injured. Said ④ SANTO BISWAS, tried to disrobe my mother and also assaulted her on her persons. Seeing all these my nephew ran to my house and informed us that his grand mother is in serious condition and also informed us about the above incidents. Immediately we ran on the said spot to rescue my mother but seeing us the above named ①, ②, ③ culprits assaulted me and my said brother namely Bubai Debnath on our persons with fists and bamboos and also scratched our face with their nails. Said ④ SANTO BISWAS, son of Unknown assaulted on my head and my brother's face with 16 mm rod. As a result to our injuries we were immediately rushed to N.B.M.C.H. and were thereby admitted due to our critical condition. Now we are under treatment.
