I, SAFIYA BIBI, w/o. Md. Fitu, resident of V.U. Hagragachh,
P.O. Chhathat, P.S. Phansidewa, Dist. Darjeeling, would like
to inform you that one MD. WASEK, son of Jaddesh AC, s/o. V.U.
Hagragachh, P.S. Phansidewa, Dist. Darjeeling, who is my
neighbour and a married person, has been stalking me
and gives me illicit offers, since eight months. On 08.11.2022
I had went to N.B.M.C.&H to visit Gynecologist. When
I was at a pharmacy to buy prescribed medicines, suddenly

I met said MD WASEK on the same shop. He told me that
his wife is pregnant and they are staying at a rental
house of Dilip Barman, s/o. Lt. Rup Kanta Barman, at V.U.
Trikunikata, P.O. Sushrutagar, P.S. Maligara, Dist. Darjeeling,
for his wife's treatment purpose. He convinced me to come
with him to his room as he needs my help to take her wife to
hospital. When he took me to his room he suddenly pushed me
in, locked the door of his room and raped me twice
consequently by showing me knife and threatened me
that he will kill me if I cry out loud for help. I found that
he was lying about his wife as no one was present there.
Then he threatened me that if I disclose about all this to police or
my husband he will kill me and my seven years old kid. I was
scared and so I didn't disclose about all this to anyone. Again
on 20.04.2023 at about 12:30 A.M., in the absence of my husband
and children said MD. WASEK, quietly entered my house and
came inside my room and locked me in. He again raped me by
putting the knife on my neck and threatened to kill me instantly if I
resist him and shout. He offer raping me fled away from my house.
I kept quiet all these days in fear and loss of image and sanctity
of me. Today 27.05.2023 at about 11:30 A.M. he blocked my way
to market and told me that he will rape me again. When I came
back home I finally informed about all the above incidents
to my husband.
