Sub: - Written complaint against 01(one) TOTO Driver plying illegally at Sevoke Road(Near IX/X Crossing) without any valid documents causing obstruction to public way.

Sir,

I ASI, Manoj Pradhan of Panitanki Traffic Guard, SPC beg to lodge a written complaint that on 28.05.23 around 12.05 hrs, while on duty at IX-X Crossing, Sevoke road area found one TOTO without any registration number stationed near IX-X Crossing, Sevoke road in such a way blocking the free flow of traffic and causing hindrance and danger to the general public and other vehicles.

Accordingly I detained said TOTO and on being asked the driver disclosed his identity as Bakul Miya (35 Yrs), S/O- Abdul Hamid Miya of Golena Hati, P.O-Golena Hati, Dist-Cooch Bihar . Further on being asked to produce relevant documents in support of his claim of plying TOTO on Major Road he failed to produce any valid documents. Thereafter I seized the TOTO and arrested the person under section 41 Cr. PC in c/w the case after observing all rules and formalities.

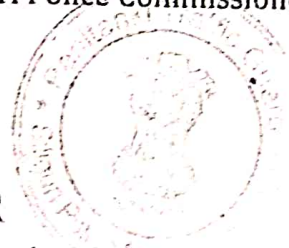
Therefore I would request you to kindly start a specific case against the above noted person (TOTO Driver) under proper section of law from your end.
