6. That till date he is threatening me with my life which has deteriorate my mental & physical health to such an extent that it has become impossible for me to live with such mental agony , depression and suffering .

Therefore, I humbly request before your gracious authority to take immediate legal action into the matter otherwise I will suffer irreparable loss and injury in my both person and mental health and take a strong action against him for the end of justice ,and for this act of kindness complainant shall be duty bound shall ever pray.
