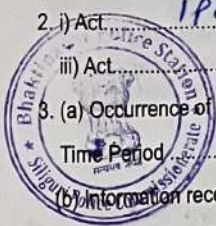

Sir,

In producing herewith the following 03 (three) persons arrested namely 1. Bijoy Mahato (M/22yrs) S/O- Kapil Mahato of Prakash nagar, Sahani Busty, W.No- 43, P.S- Bhaktinagar, Dist-Jalpaiguri, 2. Guddu Mahato (M/24yrs) S/O- Lt Sudama Mahato of Samar nagar, near Sathi Sangha Club, P.O- Champasari, PS-Bhaktinagar, Dist-Jalpaiguri 3. Aniket Chowdhury (M/19yrs) S/O- Dharmindar Chowdhury of Samar nagar, Battala, P.O- Champasari,, P.S- Pradhan nagar, Dist- Darjeeling under arrest along with the following seized articles:-

1. One iron made 'Hasua' attached with wooden handle measuring about 18 inch" with handle recovered from the possession of Bijoy Mahato (M/22yrs)
2. One iron rod measuring about 24" inch recovered from the possession of Guddu Mahato (M/24yrs)
3. One iron rod measuring about 27" inch recovered from the possession of Aniket Chowdhury (M/19yrs)

1, ASI Dipak Karmakar of Bhaktinagar PS/SPC would like to lodge this written complaint against the above noted persons and 5/6 others persons to the effect that today i.e on 26.05.2023 at about 00.30 hours when myself along with, C/915 Chandra Prakash Adhikary, C/1431 Dilip Barman CV/014 Labanyamay Barman was performing night mobile duty at that time received a secret source information that a group of 08/09 persons had assembled at Near Chamra Godown, Sahani Busty under Bhaktinagar P.S with deadly weapons with a view to commit some heinous crime. Accordingly without waste any time I informed the matter to I/C Bhaktinagar PS over telephone and as per telephonic instruction we rushed to the spot to verify the veracity of the information and to work upon it.. We reached near the spot as directed by the source at about 01.05 hours and stopped at a considerable distance from above noted spot and we started walking towards the P.O with due care so that no one could anticipate our movement at about 01.15 hrs and found a group of 08/09 persons sitting there. We started approaching towards them slowly ambushing ourselves in the darkness. But unfortunately one of the people among the gang saw us and shouted "Police" at the top of his voice. Thereafter all of them started fleeing away. Anyhow, after a hot chase we could able to apprehend the 03(three) above referred accused persons. On interrogation the 03(three) persons disclosed their identity as noted above and confessed 5/6 other persons with them. They had assembled there with a view to commit dacoity after making full preparation in the house of Sahani Busty adjacent areas. Thereafter all the apprehended persons were searched in presence of the witnesses and the following articles were seized. 1. One iron made 'Hasua' attached with wooden handle measuring about 18 inch" with handle recovered from the possession of Bijoy Mahato (M/22yrs) 2. One iron rod measuring about 24" inch recovered from the possession of Guddu Mahato (M/24yrs) 3. One iron rod measuring about 27" inch recovered from the possession of Aniket Chowdhury (M/19yrs)

All the articles were seized between 01.40 hrs to 02.05 hrs issuing a proper seizure list duly signed by the witnesses and the accused persons. Thereafter all the persons were arrested between 02.05 hrs to 02.15 hrs as they had assembled for committing heinous crime.

Under the above circumstances, I pray before you that a specific case U/S 399/402 I.P.C may kindly be started against the 03 (three) persons arrested namely 1. Bijoy Mahato (M/22yrs) S/O- Kapil Mahato of Prakash nagar, Sahani Busty, W.No- 43, P.S- Bhaktinagar, Dist-Jalpaiguri, 2. Guddu Mahato (M/24yrs) S/O- Lt Sudama Mahato of Samar nagar, near Sathi Sangha Club, P.O\_ Champasari, PS-Bhaktinagar, Dist-Jalpaiguri 3. Aniket Chowdhury (M/19yrs) S/O- Dharmindar Chowdhury of Samar nagar, Battala, P.O- Champasari,, P.S- Pradhan nagar, Dist- Darjeeling and 5/6 other persons for assembling with deadly weapons with a view to committing dacoity.
