With due respect, I, Smt. Bina Biswas, Wife of Late Fatik Biswas, residing at Lenin Sarani, Bidyachakra Colony, Ward No. 44 of S.M.C., P.O. Sevoke Road, Siliguri, P.S. Bhaktinagar, Dist. Jalpaiguri-734001 (W.B.), beg to lodge this complaint with your good office to the following effects:-

- 1) That I am a citizen of India and I am aged about 70 years old and I am a helpless widow and I am suffering from various illness.
- 2) That I am the owner of a homestead land measuring about 0.0298 acres, recorded in R.S. Plot No. 244 (P) & 341(P), Khatian No 1 & 163/4, under Mouza Dabgram, J.L. No. 02, Sheet No. 07, P.S. Bhaktinagar, Dist. Jalpaiguri.
- 3) That my son i) Sri Pradip Biswas, my daughter-in-laws namely i) Smt. Reba Biswas, Wife of Late Ajit Biswas, ii) Smt. Aloka Biswas @ Mousumi Biswas, Wife of Late Goutam Biswas, iii) Smt. Mira Biswas, Wife of Sri Pradip

(Smt. Pratima Biswas)

Biswas, iv) Smt. Pratima Biswas, Wife of Sri Biswajit Biswas, grand-sons namely i) Surojit Biswas, Son of Late Ajit Biswas, ii) Pritam Biswas, Son of Pradip Biswas, iii) Sri Rupam Biswas, Son of Pradip Biswas, grand-daughters namely i) Priyanka Biswas, Wife of Chayan Roy and Daughter of Late Goutam Biswas, ii) Payel Biswas, Wife of Nityananda @ Nishit Dey and Daughter of Late Goutam Biswas, iii) Priya Biswas, Daughter of Late Goutam Biswas and iv) Mampi Biswas, Daughter of Sri Pradip Biswas have been harassing and creating torture upon me since last few years and captured my above mentioned land by evicting me forcibly from my above mentioned land.

- 4) That on 16.05.2023, I informed the said matter to the Ward Councilor of Ward No. 44 of Siliguri Municipal Corporation in writing and also informed the same to the local club namely Bidyachakra Sporting Club and also to the Ward Secretary of Ward No. 44 of Siliguri Municipal Corporation.
- 5) That the Councilor advised me to settle the matter amicably and requested me to sit on a meeting with the above persons and accordingly, a meeting was held today i.e. on 25.05.2023 inside the Bidyachakra Sporting Club.
- 6) That in the said meeting, Councilor of Ward no. 44 of Siliguri Municipal Corporation and some other local people

were also present and they requested the above named persons not to create any torture upon me but they did not listen to that rather they became furious and tried to assault me but they could not succeed.

- 7) That when the meeting was over and I was going to my home, suddenly, the above named persons attacked me and they assaulted me by fists and blows on my nose, mouth and head and for which, I sustained bleeding injury and they also pushed me on the ground and kicked on my chest and they have also snatched my golden chain from my neck.
- 8) That thereafter, local people saved me from the hands of the above named persons and they took me to the Siliguri District Hospital for treatment.

So, I therefore, request you to look into the matter and take necessary legal action against my son namely i) Sri Pradip Biswas, my daughter-in-laws namely i) Smt. Reba Biswas, Wife of Late Ajit Biswas, ii) Smt. Aloka Biswas @ Mousumi Biswas, Wife of Late Goutam Biswas, iii) Smt. Mira Biswas, Wife of Sri Pradip Biswas, iv) Smt. Pratima Biswas, Wife of Sri Biswajit Biswas, grand-sons namely i) Surojit Biswas, Son of Late Ajit Biswas, ii) Pritam Biswas, Son of Pradip Biswas, iii) Sri Rupam Biswas, Son of Pradip Biswas, grand-daughters namely i) Priyanka Biswas, Wife

of Chayan Roy and Daughter of Late Goutam Biswas, ii) Payel Biswas, Wife of Nityananda @ Nishit Dey and Daughter of Late Goutam Biswas, iii) Priya Biswas, Daughter of Late Goutam Biswas and iv) Mampi Biswas, Daughter of Sri Pradip Biswas, - all are residing at Lenin Sarani, Bidyachakra Colony, Ward No. 44 of S.M.C., P.O.
