I wish: Rai, R/o Chayan pata
near old wine shop, o/o Lt. Bharat Rai,
would like to state that today around
6:30 AM when no one was around and
taking the advantage of it two person
Name Pkaranjit mandal and Sujit mandal
claiming as to be police officer
enter into our house and started to
measure our house permissis to break
it. We humbly ask them to show police
id card court paper to enter our house
But suddenly they started to misbehave
with us. They told us to give a
sum of 25 lakh of money as a land
extortionation money. They also mentioned
that both of them are send by

by Ratan mahanto & Jay Ram mishra.
We tried to stop them, but they use
abusive words and assaulted us. They also
threaten us saying that they are powerful
people and all the police are in their
pocket. And no one can protect us from
them. They also put me & my family in
fear of murder & rape of my daughter.

When I started screaming for help one
of them twisted my hand in such a
way that I cried in pain. Being so
helpless and weak I was unable to
save myself from them. After seeing
this my daughter started to throw
stone at them to save me. They
immediately ran away leaving their
motor bike no. WB 74 40067 inside
our home premises (after that police
came and took the bike with them giving
us a copy of seizure list) one of
them claim to be a police officer
and bring police force to arrest us.

They also came yesterday on 26/05/23
around 9 o'clock to threaten us
demanding money as extortion and
if were unable to bring money they
being people and forcefully vacate
our land.

These people Ratan mahanto, Prasanjit mandal, Sujit mandal & Jay Ram Mishra are local goons & dangerous knowed land maffias. There was not the first time they assulted & tempur out house.

I kindly request you to take strict action against them because there people are dangerous in nature & my & my daughter life are in danger.
