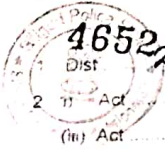

Sir,

I, Dilawar Khan, s/o of Late Md. Islam Khan, resident of Mia Garage Building, Hill Cart Road, ward no. VI of Siliguri Municipal Corporation, Siliguri, Police Office and Police Station - Siliguri, District- Darjeeling, Pin- 734001 would like to inform you that yesterday at around 4.30 P.M. when I was with my friends at Bortala Mandir at Timbalpara, I saw my elder son namely Yasir Khan in a scooter with an unknown person, after seeing me my son stopped and elaborated that when he along with his younger brother namely Rehan Khan and friends were about to start playing cricket at Kishore Sangha Maat, ward no. 4 of S.M.C, Siliguri almost 8 to 10 boys under the leadership of a boy namely Arman resident of Koila Depu, Ward No. 7 of S.M.C, Siliguri came to them and stated them to leave the ground as they want to play and altercation started within my sons along with their friends and Arman and his friends and seeing this my son friends fled away from the spot.

Later suddenly the said Arman and his friends started hitting my elder son Yasir Khan with hand and legs causing injury in his head, neck and face. Seeing this my younger son namely Rehan Khan tried to save my elder son for which they became more aggressive and started hitting my both the sons with wicket and bat till the wicket was broken in which my both the sons were severely injured and some unknown person helped them and one son was taken to Siliguri Hospital for treatment and other met me while going to hospital near Bortal Mandir.

When we went to Siliguri Hospital my younger son namely Rehan Khan was severely injured and was suggested to be immediately taken to neurologist and we took my son to Sanjeevani Neuro and Multi Speciality Hospital where he was admitted at ICU with head injury, bleeding from mouth, vomiting, seizure.

They almost killed my son and my younger son namey Rehan Khan is admitted in hospital fighting for his life. So, I request you to take necessary action against the said Arman and his friends.
