Sub:- Written complaint against unknown miscreants for unnatural death of my husband.

Respected Sir,

I, Smt. Bharati Ghosh Mondal, W/o Lt. Abhijit Ghosh of Tumba Jote, P.O. & P.S. Matigara, Dist. Darjeeling, would like to draw your kind attention to the following effect that on 20.05.2023 at about 2:15 P.M. my husband (Now deceased) went to Matigara side for his personal work, by saying that within a short time he will return home and I rang him at about 7:30 P.M. to come home, then he told me he was in Diamond Club, Matigara and enjoying the IPL and he will return 10:30 P.M. however I again rang him on 9:30 P.M. to come home, then my husband told me that he will visit Netaji Club at Pradhannagar on the eve of Bachelor Party, thereafter he will return home. But on 10:55 P.M. one Souvik Dey @ Banti (Cell Phone No. 97496-98260) rang me and told me that my husband was lying on a road in a senseless condition thereafter again told me that he never visited in club premises but again told me that he may be felt down from staircase but they did not know anything about the same but requested me to open the door he alongwith his friends came to our house with my husband, accordingly I eagerly wait for them and aforesaid Souvik Dey @ Banti alongwith another 3 persons carried my husband in a senseless condition at about 11:15 to 11:20 P.M. and they advised me not to disclosed the matter anyone because he consume excessive alcohol, next day he will be ok. But since 4:30 A.M. the blood was oozing from the nose and mouth of my husband (Now deceased), for which I contacted with aforesaid Souvik Dey @ Banti from my cell phone, but he did not picked up my phone but another friend Ajay Singh picked up my phone but he told me that he would not come and advised me go to the hospital by a TOTO, thereafter some old friend and neighbours were came in our house on my request then I alongwith them took my husband (Now Deceased) at NBMC & H, wherein CT Scan was done and doctor told me that my husband sustained injury on his head / brain, immediate batter treatment is required, for which we immediately rushed to the North Bengal Medica nursing home, where form attending doctor Dr. Digant

Jayant Kamdar told us there is too late and send my husband in ventilation and after 4 days the patient was shifted in NBMC & H and ultimately on 25.05.2023 in the evening time my husband was expired. So my strong presumption is that some persons are tried to withhold the truth and hatched up a deep rooted conspiracy for unnatural death of my husband. My husband's phone number is 93823-44694. Some unintentional delay is appeared to lodge this complaint of my ill mental health due to death of my husband.

In view of above you are requested to take appropriate legal action/ actions against the unknown mistreatments for unnatural death of my husband through cell phone / tower location, etc. as per law.
