Dear Sir,

I, Sri Abhishek Roy, S/O Jagadish Ch Roy, Station Manager, Customer Care Centre Matigara, WBSEDCL , P.S Matigara do here by lodge this complain against Nitin Gupta, residing at Sri Ram Colony, Sevoke Road, Dist : Darjeeling mob no : 8101669585 to the effect that today (29.05.2023) at about 16.00 hrs in pursuance of a tip off about unauthorized use of electricity , myself along with Pranab Sikdar, S.O S&LP of Darjeeling Regional office, WBSEDCL , Amarasish Mahandeo DE (S&LP) Darjeeling Regional office, WBSEDCL, Bhsuan Lama (ACM), Sourav Sarkar (Sr. OE), Sanjoy Ram and other staff have been to the place of question Queen's Residency at Salbari Bazar, opposite of Greenwood hotel, P.S : Pradhannagar, Dist Darjeeling.

During inspection it has been observed that said Nitin Gupta is a Commercial consumer of WBSEDCL having ID no 402385968 and meter no: LF542560 for his Common load of Queen's Residency Contractual **load was 7 KW.** On enquiry it is also learned that the illegal usage of bypassing meter for water pump is going on for **approximately last One year. Total 1.44 KW load is found as theft load for the water pump starter unit.**

Hence prepare notice, inspection memo by mentioning all minute details, as observed and also seized the meter in question with approx. 10 Mtr PVC wire after preparing the proper seizure list duly signed by witnesses, representative of Nitin Gupta refused to sign in all documents. All documents are attached to the wall of Queen's residency for future reference. Remove the meter from the place after observing all technical formalities.

So it is requested that a case under section 135 (1) (a) of Electricity Act for Nitin Gupta may please be registered and arrange for its investigation.
