Madam,

I, Swati Chaki, wife of Biswajit Biswas, daughter of Late Prabandha Kumar Chaki, resident of Deshbandhupara, near Sarada school, Siliguri- 734004, got married to my husband on 5th March, 2023 at Mahamaya Kalibari which is situated at Deshbandhupara, near Indore stadium, Siliguri-734004. From the very beginning of our marriage my husband used to torture me physically and mentally. Without any reason he used to hit me. After some days of our marriage, he started doubting me with his father and for that he used filthy language towards me which I can not even mention. My husband did not want me to talk anyone. His doubtful nature increased to that extent that he used to threaten me that he will kill me if I talk to anyone. Once I was sick and I wanted to go to my house, nobody allowed me to go to there rather he threatened me that he will try every possible way to cut off my contact with my mother and he will snatch my phone and lock me in the room. When I started protesting for that he used to threaten me that he will beat me and give divorce. I stayed my matrimonial home about one and half months and tolerate all this stuff. I have conveyed all these to my father-in-law and sister-in-law, but they are not bothered and did not take any action. On 18th April, 2023 I was sick due to headache, fever and menstruation problem, for that reason I did not get up early. My husband called me and threatened me that he will come on 21st April, 2023, he will beat me with belt and he also called my mother and used slang to my mother. Due to physical and mental torture already became weak and I got scared that I could not find another
