Sir,

This is to inform you that, a comenveaney worker of Siliguri Municipal Corporation (SUDA), named Shri Poto Muzmu, S/o of Shri Shaona Muzmu, Under Borough Office, No. IV, met an accident today, i.e. 20-05-2023 at around 10:30 a.m. at Tinbatti More, Asian Highway 02. He was on duty, He is going to the place of work.

Accident occurred due to rash and negligence driving of driver of the vehicle No. WB73D, 8558. The vehicle hit the person from back side, Mr. Poto Muzmu, got injured badly. Local people and on duty police officer present at spot, resqued him and took him to North Bengal Medical College & Hospital. The person died after some time at North Bengal Medical College & Hospital. We are lodging a FIR on this issue and requesting you for further necessary
