Sir,

In producing herewith two arrested accused persons namely (i) Tapash Roy Pradhan (38 yrs), s/o – Dharendra Nath Roy Pradhan of Pradhan Para, Belacoba, PS – Kotwali, Dist – Jalpaiguri (ii) Akash Roy (38 yrs), s/o - Lt. Arabinda Roy of Balarampur, PO- Balir Hat, PS – Tufanganj, Dist – Coochbehar along with the following seized articles as per proper seizure list

(1) One Truck (Saktiman) bearing display no. WB-73-8319 loaded with approx 12 (twelve) CFT sand, seized from the possession of Tapash Roy Pradhan (Driver of the Truck).

(2) One Truck (Saktiman) bearing display no. WB-73-8744, loaded with approx 20 (twenty) CFT sand seized from the possession of Akash Roy (Driver of the Truck).

I, ASI. Biswajit Ghosh of Ambari Falakata Out Post under NJP PS/SPC lodged a written complainant against the above noted persons to the effect that on 21.05.2023 at 14:35 hrs myself along with C/ 393 Shyamal Roy, C/625 Bhabendra Das & NVF 130 Dhanadeb Roy, all of Ambari-Falakata OP, PS. NJP/SPC detailed for performing special raid duty. In course of raid duty at about 14.35 hrs. I received information from my source that two Saktiman Truck loaded with sand coming from Balaram Hat without any document. Accordingly I informed the matter to O/C Ambari-Falakata OP over telephone and as per his direction, myself along with force arrived at Balaram Road. This refers to Ambari-Falakata OP GDE No. 707 dt. 21.05.23. At 15.05 hrs we reached at Balaram road and found two Saktiman Truck bearing No. WB-73-8319 & WB-73-8744 loaded with sand coming from Balaram Hat side. Seeing the Police party the driver of said Saktiman Trucks tried to flee away, but managed to intercept the above noted Saktiman Trucks with drivers. On interrogation, the above noted persons disclosed their name and identity as (i) Tapash Roy Pradhan (38 yrs), s/o – Dharendra Nath Roy Pradhan of Pradhan Para, Belacoba, PS – Kotwali, Dist – Jalpaiguri (ii) Akash Roy (38 yrs), s/o - Lt. Arabinda Roy of Balarampur, PO- Balir Hat, PS – Tufanganj, Dist – Coochbehar. On being asked, the above noted accused persons failed to produce any valid documents for possessing the sand inside the Saktiman Trucks as well as the documents of Saktiman Trucks. There is sufficient reason to believe that the above noted drivers have stolen those sand from Sahu river without any legal royalty/ papers as per rule, for selling clandestinely. Accordingly, I seized both Saktiman Trucks loaded with 12 (Twelve) CFT & 20 (twenty) CFT Sand respectively under proper seizure list and arrest the above noted persons U/S 41 Cr.P.C informing them the ground of arrest after issuing Memo Of Arrest. The search, seizure and arrest were made in between 15.45 hrs and 16.15 hrs.

I, therefore request you a specific case may kindly be started against the accused persons namely (i) Tapash Roy Pradhan (38 yrs), s/o – Dharendra Nath Roy Pradhan of Pradhan Para, Belacoba, PS – Kotwali, Dist – Jalpaiguri (ii) Akash Roy (38 yrs), s/o - Lt. Arabinda Roy of Balarampur, PO- Balir Hat, PS – Tufanganj, Dist – Coochbehar and owners of the above noted seized Saktiman Trucks under proper section of law.
