Sir,

I Md. Sajjad (19), the above noted Complainant beg to inform you that on dt. 25.05.2023 at night, my elder brother namely, Md. Azad S/o Md. Safi Ahmed came out of NJP Railway station and reached at Parking place in front of said station at about 9:30 pm, at that time, one Md. Arman S/o Md. Aris of Raja Holi, Ward No. 35 SMC PS-NJP, Distt-Jalpaiguri, alongwith his other unknown associates, started abusing my said brother in filthy languages and when he protested, they attacked him with iron rod (iron angle to open the shutter) and injured my said elder brother, Md. Azad grievously, his friends, namely (1) Md. Firay (24) S/o Md. Semim (2) Md. Israail @ Oaddu S/o Not known & (3) Md. Sahajada S/o M.L. Astum, reached there after sometime and immediately, shifted my said elder brother namely Md. Azad S/o Md. Safi Ahmed of Coal Depo, Near Lokamaath, Vivekananda Nagar Ward No. 7 SMC, PO-Siliguri Bazar, PS-Siliguri Distt-Doojooly, to Paramount Hospital, Khulpura, Siliguri, and admitted him there in serious condition, later on he revealed the fact that, said alleged person namely Md. Arman & his unknown associates, stole away Rs. 2200/- (Rupees Two thousand two hundred) only from my brother, Md. Azad after physically assaulted him brutally with iron rod (angle). So, please take necessary action against said Md. Arman & his unknown associates.
