
In this regard, I SI Chabilal Singha of Matigara P.S, SPC do hereby lodge this Complaint against above noted arrested accused person to the effect that on 29.05.2023 at about 16:35 hrs onwards I received a source Information that one vehicle one vehicle Dumper bearing Reg. No. WB - WB - 73 F/4712 loaded with river bed materials coming from Tarabari Ghat side without any valid documents. Accordingly I inform the fact to Officer In charge, Matigara PS and as per his kind direction I along with force had been to Tarabari under PS Matigara to work out the information in hand. After arrival of the spot, I found said vehicle Dumper bearing Reg. No. WB - WB - 73 F/4712 loaded with river bed materials standing at Tarabari side under Matigara PS area. Accordingly, I apprehended the driver of the vehicle. On demand he failed to produce any valid documents in respect of river bed materials loaded in his vehicle. On further interrogation, he stated that he mines such river bed materials from Tarabari Ghat by illegal means with a view to sell the same for his illegal gain. Accordingly, I seized the above noted vehicle loaded with illegally mining river bed materials under proper seizure list and arrested him after maintaining all formalities regarding arrest.

Therefore, I pray before you that a specific case under proper section of law may kindly be started against the arrested accused person namely Sanjoy Kumar Roy (39), S/O Saben Roy of Panchkelguri (kalu Ghat), PS - Matigara, Dist- Darjeeling or the owner of the vehicle and arrange for its investigation.


