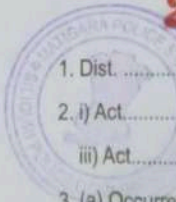

With due respect I would like to inform you that I Smt. Jayanti Murmu, D/o- Lt. Nabin Murmu, residing at Rahutara, Po- Rahutara, Ps - habibpur, Dist- Malda, West Bengal. I was took admission in St. Fernando College of Nursing, Webel IT Park, Paribahan Nagar, Matigara, Siliguri- 734010 for the study of GNM Nursing Course on Septambar 2022. And my friends 1) Shrestha Sarkar, D/o- Gobinda Sarkar, Village Bowlmari, Dist- Jalpaiguri, 2) Arpita Roy, D/o- Binay Roy, from Cooch behar District, & 3) Jannatun Ferdousi D/o- Jakir Hossan, from Coochbehar District, At the time of admission the head of the college Md Mukhtar Sekh was committed us that they completed the Nursing course from "Vanshika College of Nursing" at Bangalor, which is a INC approved Institute, but after 8 month latter the College authority declare that the examination of the GNM Nursing course of their college student will held indifferent unknown Institute at Bangalor, but did not declared the name of the college still 8 month later . When I went to the college the authority and the owner Md Mukhtar Sekh do everything for show and every words told lie and I realize that every act of then is false and fabricated and fraud. After that I was visit in St. Fernando College and ask to the head of the department Md Mukhtar Sekh that why he did not declare the College for my Nursing course and why he did not inform to me or my guardian before admission of the this St. Fernando College of Nursing. When I ask this to Md Mukhter sekh and his staff authority they insulted me in front of their all office staff and publice in this college building and throw me from the office of said Md Mukhter sekh and his staff authority. They using slang languages and throw me said languages for insulted me as a ST/ SC cast.

Sir it is very painful for me and my friend that we are totally cheated and fraud by said Md Mukhter Sekh and the staffs and authority of said St, Fernando College of Nursing, because they took money

from my guardian but issue illegal kachha money receipt against said payment and which document they issue in favour of me and my friend all that papers have no registration numbers of this said institute, and they continually make pressure to my guardian for money, if my guardian did not pay their demand money in that case the authority and staff are tortured me as a ST/SC Cast and separate me from my friends at Hostel and in that case my guardian bound to pay the money, my guardian already pay the amount of Rs. 1,25,000/- (Rupees One Lakh Twenty Five Thousand) only and my friends are also paid said amount for their Nursing course but the college authority did not issue the legal money receipt in faver of me and my friend they also took my and my friends orginal document in their custody and in any condition they did not handed over me and my friends original documents.

Sir it is request to you that please investigate about that St. Fernando College because they illegally, fraud and falsely run this college and spoiled the future of student like me and friends. They will cheat and fraud everybody and torture the student at their hostel for money and many illegal works are done at the hostel of said St. Fernando College. I was lost my one year education carrier and also loss the money and prastiage of my guardian as a SC/ST Cast. So, it is my humble request to you that please take necessary action against said St. Fernando College and the owner Md Mukhtar Sekh and the staff and authority of said College and recover my Money and document from their custody, because the owner and staffs are told lie and give false information and commitment to me and my friends and took said money and document from me. It is for your kind information that one Priyanhshu Sharma was also file a complaint against said St Fernando College of Nursing in your Police station and he is our Senior Student. So, Please Take necessary action against said College and authorizes and give justice for spoiled our students carrier.
