Sir it is very painful for me that I totally cheated and frod by said Md Mukhtar Sekh and the staffs and authority of said St, Fernando College of Nursing, because they took money from my guardian but issue illegal kachha money receipt against said payment and which document they issue in favour of me in that paper have no registration numbers of this said institute, and they continually make pressure to my guardian for money, if my guardian did not pay their demand money in that case the authority and staff are tortured me at Hostel and bound to pay the money, my guardian already pay the amount of Rs. 1,55,000/- (Rupees One Lakh Fifty Five Thousand) only but the college authority did not issue the legal money receipt in faver of me
